Sealed bids are invited from the registered firms/contractors for the above mentioned services. Firms/contractors having at least Five (05) years experience for providing similar services to five star hotels, large hospitals, well established public or private enterprises or multinational organizations and have successfully completed at least two similar jobs/contract of Rs.1.5 million per annum or more during last Five (05) years shall be eligible to participate in bidding.

The amount of earnest money/bid security for the above tender is 2% of the bid amount (2% of total bid amount for 12 months) payable in the form as specified in the bidding documents in favour of State Bank of Pakistan, SBP-BSC (Bank), Faisalabad. Bidding will be conducted on National Competitive bidding basis under the provision of Public Procurement Rule-36(b) single stage-two envelop Procedure of PPRA Rules-2004. Bids must be sealed in one outer envelope containing the Technical and Financial Bids in separate sealed inner envelopes, name of bidder and Tender Description as per the details given in bidding documents shall be marked on each envelope. Bids should be dropped in the Tender Box kept in the office of **Chief Manager, 2nd Floor, M.A. Jinnah Road, Near G.T.S. Chowk, State Bank of Pakistan, SBP-BSC (Bank), Faisalabad** by or before **24-Feb-2015** till **3.00 PM**. Technical proposals shall be opened on the same day at **3.30 PM** in the presence of the bidders or their authorized representatives who may like to attend the session.

Financial bids of technically qualified bidders shall be opened in the presence of the bidders or their authorized representatives who may like to attend the session, at the time and venue communicated to the technically qualified bidders in advance. In case of any unforeseen reasons, unrest or force majeure on the bid submission/opening date, the tender shall be opened on the next working day at the same place and time. The bids shall remain valid for minimum period of 90 days from the date fixed for submission of the Bids. No bidding documents shall be sold on the date fixed for opening of the bids. Incomplete, conditional and bids without appropriate earnest money shall not be considered. This tender Notice is only an invitation to offer and Bank reserves the right to accept/reject the bids as per PPRA Rules. Further, personal canvassing, recommendation or unauthorized practices for getting the Contract will also disqualify the bidders.
