Sealed Tenders are invited for the above job from the competent Electrical / Mechanical contractors / contracting firms with documentary proof of have done similar jobs in last 05 five years of overhauling express lifts and replacement of faulty parts of lifts.

Complete set of Tender Documents can be obtained free of cost from the office of Engineering Division at 4th floor, M.A. Jinnah Road, Near GTS Chowk, SBP-BSC (Bank), Faisalabad on or before 19th Jun, 2015 till 10.00AM after producing / showing documentary evidence of completing 03 similar nature jobs during last 05 years.

Bidding will be conducted under National Competitive Bidding Procedure specified in the Public Procurement Rules 2004 (PPRA-2004) as per Rule-36(a), <u>under Single Stage</u>, and <u>Single Envelopes procedure</u>. The name of the bidder and tender description shall be clearly marked on all envelopes.

The amount of Earnest Money for the job is 2% of the quoted amount payable in the form of Pay Order/Demand Draft in favor of State Bank of Pakistan, SBP-BSC (Bank), Faisalabad. Tenders along with requisite Earnest Money should be dropped in tender box kept in the office of the PA to Chief Manager at 2nd floor, M.A. Jinnah Road, Near GTS Chowk, SBP-BSC (Bank), Faisalabad on or before 19th Jun, 2015 till 11:00 AM. The Bid shall be opened at office of the Chief Manager at 2nd floor, M.A. Jinnah Road, Near GTS Chowk, SBP-BSC (Bank), Faisalabad on same date at 11:30 AM in the presence of bidders or their representatives who may like to attend the session. No tender documents shall be accepted after opening of the tenders. In case of any unforeseen reasons, public holiday, unrest or force majeure on the bid submission/opening date, the bids shall be opened on the next working day at the same place and time.

Incomplete, conditional and bids without 2% of bid amount as earnest money shall not be considered responsive. These tenders are only invitation to offer and Bank does not bind itself to accept the lowest or any tender as per PPRA rules. Further, personal canvassing, recommendation or unauthorized practices for getting the Contract, will also disqualify the bidders.

Instructions for bidders:

- 2. If the bidder needs any clarification / information, he should contact the Bank well before the date of opening of quotations.
- 3. Quoted price should be inclusive of all Government taxes, levies and etc, as applicable.
- 4. Quoted price should be firm and final and no rebate will be accepted after the opening of quotation.
- 5. Quoted rates should be valid for 90 days.
- 6. Quoted price should be mentioned in words and figures both. In case of error price mentioned in words will be considered as correct.
- 7. Time for the completion of job is 02 months from the date of work order and contract execution.
- 8. Warranty for replaced parts shall be one year from the date of successful installation of parts of lifts.
- 9. Quantity of the BOQ items may be increased or decreased.
- 10. The bidder who may not be able to perform after award of work will be blacklisted and their security will be forfeited. Further, contract will be awarded to the next lowest bidder.
- 11. Those contractors who were failed to perform in the past with State Bank of Pakistan, SBP-BSC (Bank) are not eligible to apply.
