Tender Notice

1. State Bank of Pakistan, SBP BSC Karachi invites sealed bids from tax registered eligible bidders for *"Supply of Carpeted Jay-e-Namaz & Cotton Dari/Suff"* for mosque at Main Building, State Bank of Pakistan, I.I. Chundrigar Road, Karachi.

2. Bidding will be conducted under National Competitive Bidding pursuant to 'Single Stage-One Envelope Procedure as per Rule 36(a) of Public Procurement Rules 2004 (PPR-2004) and is open to all eligible bidders as defined in the PPR-2004 that meet the following minimum qualification criteria:

Qualification Criteria

Bidder must be a manufacturer / importer or a direct authorized agent of the manufacturer / importer of required item as mentioned above in Pakistan with a minimum of three (03) years of experience in manufacturing or supplies; as applicable. Agent should be in possession of a consistently valid authorization certificate where applicable. Manufacturer/supplier should have a documented track of completing at least three (03) similar assignments during last three (03) years involving the supply and installation of Carpeted Jay-e-Namaz & Cotton Dari/Suff to a comparable scale. Bidder must be registered with Income Tax and Sales Tax Department. Annual sales volume/gross turnover of the individual bidding firm should be at least Rs. 10 Million in any of last three years.

3. The detailed specifications of the items to be supplied must be provided with the bid.

4. Evaluation of bid and contract award will be performed in line with the criteria laid down in the bidding document.

5. The Bidders are requested to give their best and final prices as no negotiations are expected. The rates quoted must remain valid for a period of ninety (90) days after opening of bids.

6. All bids must be accompanied by sample Jay-e-Namaz & Cotton Dari/Suff and a bid security of not less than 2% of the bid price in the form of Pay Order/Bank Draft in favor of State Bank of Pakistan SBP-BSC Karachi. If items specified in technical specifications are quoted as options, cost of the highest option would be used to calculate the bid security. Late bids will be rejected. Bids submitted without signed Bid Form by authorized nominee of the bidder will also be rejected. Bid with material deviation, exception, objection, conditionality or reservation shall also be rejected under PPR-2004.

7. Interested eligible bidders may obtain the bidding document from the address given below during office hour at least one day before last date of bid submission on payment of Rs. 600 (non-refundable) in the form of Bank Draft/Pay Order in favor of SBP-BSC Karachi Office.

8. Bids must be delivered to the address below on or before May 13, 2015 at 11:00 A.M. Bids will be opened in the presence of bidders' representatives who choose to attend at 11:30 A.M. on same day in the meeting room of *SBP Banking Services Corporation*, 2^{nd} *Floor, Main Building, I. I. Chundrigar Road, Karachi.*
