State Bank of Pakistan, SBPBSC (Bank) invites sealed Tenders from the Contractors/ Contracting firms who are enlisted with Pak. P.W.D., M.E.S., Quasi Government Body, State Bank of Pakistan, Engineering Council or any reputed organization, shall be eligible to participate in the tender.

Tender Documents can be obtained from the office of Executive Engineer, Engineering Department, (Phone # 021-32454150) SBP's Boulton Market Building, M.A.Jinnah Road, Karachi on payment of **Rs.1000/-**(non-refundable) fees on submission of written request/application along with Demand Draft/Pay Order. Bidding will be conducted using National competitive Single Stage Two Envelope procedure as specified in the Public Procurement Rule 36(b)-(PPRA-2004). Technical and financial proposals should be sealed in two separate envelopes and be placed in 3rd envelope. The name of the bidder and tender description (Name and technical or financial proposal) shall be clearly marked on all envelopes. Bids shall be evaluated on the basis of **Bid Evaluation Criteria** given in the tender documents. After the evaluation & approval of the Technical Proposals, Financial Proposals of the technically accepted bids shall be publicly opened at a time, date and venue, to be communicated to the qualified bidders in advance.

Bidders must have documented track record of completing at least 03 similar assignments /jobs in the past 03 years. Bidder must have OEM certificate of Siemens PABXs.

The Bidder must submit Earnest Money (refundable) equal to 2% of the total quoted amount payable in the shape of Bank Draft/Payment Order /Call Deposit in favor of State Bank of Pakistan, SBP-BSC (Bank), Head Office, Karachi. Conditional, Incomplete tender & tender without or less than 2% Earnest Money as mentioned above and Bidder not fulfilling the above mentioned requirements shall be considered as non-responsive. Bidders are requested to give their best & final prices as no negotiations is allowed. The rates quoted should be valid for a period of 90 days from the date of bid opening. Further, personal canvassing or recommendations will disqualify the Bidder(s). Bid(s) not submitted on Bank's prescribed format/BOQ will also be considered as non-responsive.
