 - c. Registered with Sales Tax Department (Valid GST Certificate required).
 - d. Valid registration with Pakistan Engineering Council (PEC) in category C-6 or above and appropriate specialized category i.e ME03 is mandatory whereas EE03/EE04 will be considered in addition.
 - e. Bidder should have completed minimum 03 work (s) of similar nature & complexity and product brand in the last 05 years.
