For above Tender, complete set of Tender Documents, Specifications and/or Drawings can be obtained from the Engineering Division Office at 6th floor Main Building SBP BSC (Bank), Lahore, against payment of Rs. 1,000/-(Rupees One Thousand only) separately for each tender in the form of Pay Order/Bank Draft /Cash (Non-Refundable) as Tender Fee. The contractors/ contracting firms are also required to furnish along with their application for issuance of Tender Documents, the following information/ documentary evidence;

- i. Copy of valid registration certificate with Pakistan Engineering Council.
- ii. Copy of Income Tax Registration Certificate.
- iii. Copies of work orders or completion certificates for two completed similar jobs during last three years.

Bidding will be conducted under National Competitive Bidding Procedure specified in the Public Procurement Rules 2004 (PPRA-2004) as per Rule-36(b), under Single Stage, and Two Envelopes procedure. For above Tender, Technical and Financial proposals should be sealed in two separate envelopes and be placed in 3rd sealed envelope. The name of the bidder and Tender description (Name and technical or financial proposal) shall be clearly marked on all envelopes. Earnest Money will have to be enclosed in the envelope of Financial Proposal. Bids for each Tender will be treated, evaluated & contracts will be awarded separately.

The amount of Earnest Money for the Tender is 2% of the bid amount payable in the form of Pay Order/Bank Draft (Cash not acceptable) as specified in the bidding documents, in favour of State Bank of Pakistan SBP BSC (Bank)

Lahore. Tenders along with requisite Earnest Money should be dropped in tender box kept in the Office of the PA to

Currency Officer at 3rd floor Main Building SBP BSC (Bank), Lahore on or before specified time. Technical

Proposals shall be opened at the Office of the Currency Officer at 3rd floor Main Building SBP BSC (Bank), Lahore

on specified date & time in the presence of bidders or their representatives who may like to attend the session. No

tender documents shall be sold on the date fixed for opening of the tenders. In case of any unforeseen reasons,

public holiday, unrest or force majeure on the bid submission/opening date, the tender shall be opened on the next

working day at the same place and time.

Incomplete, conditional and bids without 2% of bid amount as earnest money shall not be considered responsive.

This tender is only invitation to offer and Bank does not bind itself to accept this tender as per PPRA rules. Further,

personal canvassing, recommendation or unauthorized practices for getting the Contract, will also disqualify the
