1) Sealed Tenders are invited for following job from the Contractors/ contracting firms who are registered with Sales & Income tax Department as well as Pakistan Engineering Council at least in Category C-6 and above with specialization category CE-10.

- 2) Bidding shall be conducted using National competitive bidding procedures as specified in the Public Procurement Rule-2004 under 36 (a) based on single stage one envelope Procedure. The name of the Bidder and Tender description shall be clearly marked on the envelope.
- 3) Bidders are requested to give their best & final prices as no negotiations are expected. The rates quoted should be valid for a period of <u>120 days</u> from the date of bid opening. Interested Bidders may collect the bidding documents from Engineering Unit, 2nd Floor, at SBP BSC (Bank), The Mall, Rawalpindi on submission of written request/application, during office hours on working days not later than <u>29-07-2015</u> along with Demand Draft/Pay Order of Rs. <u>500/- (non-refundable)</u> in favour of State Bank of Pakistan as Tender Fee for the job. Bidders must have documented track of completing at least <u>03</u> similar assignments / work of similar nature of Rs. <u>1.5</u> Million or more during the last <u>3 years</u>. The bidder should also provide an undertaking on Rs.100/- Non-Judicial paper, that they are not black listed by the Govt / Autonomous body otherwise they will not be eligible to bid (Affidavit to be provided).
- 4) The amount of Earnest Money (refundable) for the above tender is 2% of total bid cost in the shape of Bank Draft / Payment Order / Call Deposit in favor of State Bank of Pakistan, should be accompanied with the quotation, to be submitted in a sealed cover duly named, signed, with subject & email address boldly marked on the envelope shall be dropped either personally or sent through Registered Post / Couriers so as to reach the office of Chief Manager, SBP BSC (Bank), Rawalpindi on or before **30-07-15** at **11:00** AM. Tender will be opened on the same date at **11:30** AM in the presence of Bidders who may like to be present. In case of any unforeseen reasons, public holiday, unrest or force majeure on the bid submission/opening date, the tender shall be opened on the next working day at the same place and time.
- 5) The Bank does not bind itself to accept the Bid and reserves the right to reject the Bid(s) as per PPRA rules. Tender submitted after the scheduled time of opening shall not be entertained and shall be returned straightaway. Tender will be evaluated as per bid evaluation criteria mentioned in tender documents and work shall be awarded to only lowest evaluated responsive bid among the bids altogether.
- 6) Conditional, optional, incomplete bid, bids without required evidences and bids without or less than 2% Earnest Money of total final bid amount and not fulfilling the above mentioned requirements shall be considered as **Non-Responsive**.
- 7) Further, personal canvassing or recommendations will also disqualify the Bidder. Those contractors who have failed to perform previously with SBP / SBP BSC are not eligible to participate

in the bidding process. Bid not submitted on Bank's prescribed format/BOQ will be rejected. No Tender document shall be sold on the date fixed for opening of the tender.
