## **TENDER NOTICE**

## Floor Polish Work at Ground Floor and 1<sup>st</sup> Floor State Bank of Pakistan SBP-BSC Bank, Faisalabad

Sealed Tenders are invited from the contractors / contracting Firms for the above mentioned works. Contractors/Contracting Firms enlisted with Pak. P.W.D., Provincial P.W.D., M.E.S., State Bank of Pakistan or any multinational / well reputed national organizations and having at least 03 years experience of similar works and registered with income tax department are eligible to apply.

- 1. The amount of Earnest Money/ Bid Security for the above tender is 2% of the total bid amount payable in the form as specified in the Bidding Documents in favor of the State Bank of Pakistan SBP BSC Bank, Faisalabad.
- 2. Tender Documents can be obtained **from 4<sup>th</sup> Floor Engineering Unit at State Bank of Pakistan SBP BSC** (Bank), Near GTS Chowk, Faisalabad during office hours on working days not later than 11-03-2015 on payment of Rs. 200/- (Pak. Rupees Two hundred only) as tender fee (non-refundable) in form of cash or pay order in favour of State Bank of Pakistan with written request/application on company letter head. The applicant must have to provide the documentary proof/ evidence of at least 03 years experience of similar works and copy of income tax registration certificate while applying for issuance of the Bidding Documents.
- 3. Bidding will be conducted on the basis of National Competitive Bidding method under the provisions of Public Procurement Rules-36(a) single stage, one envelope procedure (PPR-2004).
- 4. Tenders should be dropped in the Tenders Drop Box kept in the office of the PA to Chief Manager, 2<sup>nd</sup> Floor, State Bank of Pakistan, SBP-BSC Bank, Near GTS Chowk Faisalabad, by or before the date fixed for submission of Bids i.e. 12-03-2015 till 11:00 AM. Bids shall be opened on the same date at 11:30 AM in the presence of Bidders or their authorized representatives who will like to be present.
- **5.** Tender of a bidder shall be cancelled if the bidder is found blacklisted by any organization at any stage during tendering process or execution of the Contract.
- **6.** The bid of any bidder shall be declared non-responsive if he is found involved in litigation with any government or semi-government department.
- 7. If any clarification is required, the query may be sent to the undersigned through registered courier, e-mail or fax, at least 07 days prior to the date fixed for submission of bids. All replies to the queries or addendum etc. shall be considered part of the tender documents and should be signed and submitted along with the bid.
- **8.** In case of any unforeseen reasons, unrest or force majeure on the bid submission/opening date, the tender shall be opened on the next working day at the same place and time.
- 9. The bids shall remain valid for a minimum period of 90 days from the date fixed for submission of the Bids.
- 10. Incomplete, conditional and tenders without appropriate earnest money shall not be considered.
- 11. These tenders are only invitation to offer and Bank does not bind itself to accept the lowest or any tender as per PPRA rules.
- **12.** Further, personal canvassing, recommendation or unauthorized practices for getting the Contract, will also attract disqualification of the bidders.
