TENDER NOTICE

SUPPLY, INSTALLATION AND REPLACEMENT OF ROPES OF BULLION AND PASSENGER LG LIFTS INSTALLED <u>AT STATE BANK OF PAKISTAN, SBPBSC, MULTAN</u>

Sealed tenders are invited from the companies that have valid OEM Dealership Certificate of Lifts and can provide import documents for procurement of Rope from the reputed companies for supply, installation and replacement of ropes of Bullion and Passenger LG Lifts installed at State Bank of Pakistan SBPBSC, Multan. Tender documents can be obtained from the Office of the undersigned latest by 10th June, 2015 on production of documentary evidence along with complete profile of the company including OEM Dealership Certificate of Lifts.

- 1. A set of tender documents duly signed/stamped on each page including annexure, if any, and supplementary information will be submitted by the bidders.
- The bidders should submit quotations with Earnest Money not less than 02% of the total cost of bid in the form of Bank Draft / Payment Order drawn in the favor of State Bank of Pakistan, SBPBSC, Multan. Tenders/quotations submitted without Earnest Money will not be entertained.
- 3. Quotations/Tenders not submitted on Bank's prescribed format/BOQ (Bill of Quantity/Description of work) will be rejected.
- 4. Tenders/Quotations submitted incomplete, conditional, rates quoted with options shall be rejected.
- 5. Tenders must be filled in English and all enclosed documents should also be in English.
- 6. Tenders are irrevocable and valid for acceptance for a period of one hundred and twenty (120) calendar days from the Tender opening date.
- 7. The Tenderers offer must conform in all respects with the tender documents.
- 8. Documents submitted by Tenderers in connection with the tender for above named works will be treated as confidential and will not be returned.

- 9. Tenderers will not be reimbursed for any expense of any kind whatsoever incurred in connection with preparation and submission of their tenders.
- 10. Unit rates should be mentioned both in words and figures in Pak Rupees.
- 11. The rates should be inclusive of all taxes (including GST, overheads transportation, labor charges for handling and testing at the site etc.
- 12. The Bidder should provide complete information including brochures of the equipment offered.
- 13. If the tender/bid does not meet specification and other requirement the same will be rejected even in case of lowest bidder.
- 14. The bidders should visit the site before submitting their tenders to determine the exact nature and quantum of work and site condition.

Tenders should be dropped in the sealed Tender Box kept in the Office of Deputy Chief Manager (Admn.) at 3rd Floor, State Bank of Pakistan, SBPBSC, Multan by 11.00 A.M., on 11th June, 2015. Tenders/quotations will be opened on the same day at 11.30 A.M., in the presence of Tenderers who may like to be present.

Any attempt to influence or receipt of recommendations from any outsider shall disqualify such bidder. This notice is only an invitation to offer quotations and the **Bank reserves the right to accept or reject any or all quotations at any time as per PPRA rules.**
