- 1. 1. The State Bank of Pakistan (SBP) intends to renew licenses and technical support for its in use Backup and Replication licensed software products.
- 2. Procurement Division, General Services Department (SBP BSC) invites sealed bids from eligible Bidders for *"Renewal of Symantec Backup and Replication Software Licenses with Support"* as delineated under:

- 3. Bidding will be conducted under Negotiated Tendering procedure in accordance with Rule 42 d (ii) of Public Procurement Rules 2004 and is open to all eligible Bidders as defined in the PPR-2004 who meet the following minimum eligibility/qualification criteria:
 - a. Bidders must be a Manufacturer (OEM) or an authorized Agent /Partner of the OEM in Pakistan; with a currently valid authorization certificate for at least 01 year.
 - b. Bidder should have minimum three (3) years experience of similar assignments.
 - c. The bidder should have at least one OEM certified technical resource.
 - d. Bidder must be registered with Income and Sales Tax Department.
- 4. Bidders will quote for COMPLETE REQUIREMENT, evaluation of bids and contract award will be done accordingly.
- 5. The Bidders are requested to give their best and final prices as no negotiations are expected. The rates quoted must remain valid for a period of one hundred twenty **120** (**One Hundred Twenty**) **days** after opening of the bids.
- 6. All bids must be accompanied by a Bid Security of not less than **2%** of the bid price. Bid found without / insufficient bid security will be rejected. Late bids will be rejected. Bids submitted without signed Bid Form by authorized nominee of the bidder will also be rejected. Bid with material deviation exception, objection, conditionality, or reservation shall also be rejected.
