Prescribed tender documents can be obtained from the Office of the undersigned during office hours up to 31st December, 2015 at Engineering Office, First Floor SBP Boulton Market, MA Jinnah Road, Karachi on payment of Rs. 1000/-Cash/Pay Order (non-refundable) in favor of State Bank of Pakistan & on production of Request Letter on Company's Letter Head along with copies of 03 work orders of similar nature of works issued from clients, copies of Sales Tax Certificate, Income Tax Certificate, and Company's Profile on any working day/timings.
- 3. The Earnest Money should not less be than 2% of the total quoted amount in shape of pay order (cash will not be accepted) and should be enclosed with the Financial Proposal of tender. Further, tenders without earnest money in the specified form/format, incomplete, optional and conditional bids shall be rejected.
- 4. The Bid shall comprise a single package containing two separate envelopes. Each envelope shall contain separately the "Financial Proposal" and the "Technical Proposal", and marked clearly as such. Technical and Financial proposals should each be sealed, and placed in 3rd envelope.
