TENDER NOTICE

**CONSTRUCTION OF WATCH TOWER AT STATE
BANK OF PAKISTAN, SBPBSC, MULTAN**

Sealed tenders are invited from the well reputed contractors/contracting firms or companies that have sufficient experience of the captioned job with their complete profile containing details of similar job presently being done and those carried out during the last five years with the cost supported by documentary evidence at the time of issuance of tender documents (photo-state copies along with registration with Income Tax Department for GST/Withholding Tax to be attached) and undertaking to the effect that the firm has not been black listed by any organization.

Bidders can obtain tender documents from the Office of the Assistant Chief Manager, Engineering Division, Mezzanine Floor, State Bank of Pakistan, SBPBSC, Multan latest by **01st December, 2015** for the subject job by following the under noted terms and conditions in true letter and spirit, failing which their tenders are liable to be rejected:-

1. A set of bidding documents duly signed on each page and official seal stamped on each page including annexure(s), if any, and supplementary information will be submitted by the bidders.
2. The bidders should submit quotations with Earnest Money not less than 02% of the total cost of bid in the form of Bank Draft / Payment Order drawn in the favor of State Bank of Pakistan, SBPBSC, and Multan. Tenders/quotations submitted without Earnest Money will not be entertained.
3. 10% Security Deposit will be deducted from the Bill at the completion of entire job (refundable after 06 months from the completion of job).
4. Quotations/Tenders not submitted on Bank's prescribed format/BOQ (Bill of Quantity/Description of work) will be rejected.
5. Bids submitted incomplete, conditional, rates quoted with options shall be rejected.
6. Bids must be filled in English/Urdu and all enclosed documents should also be in English/Urdu.
7. Bids are to be irrevocable and valid for acceptance for a period of one hundred and twenty (120) calendar days from the Tender opening date.

8. The Bidders offer must conform in all respects with the tender documents.
9. Documents submitted by Bidders in connection with the tender for above job will be treated as confidential and will not be returned.
10. Bidders will not be reimbursed for any expense of any kind whatsoever incurred in connection with preparation and submission of their bids.
11. Unit rates should be mentioned both in words and figures in Pak Rupees.
12. The rates should be inclusive of all taxes (including GST, withholding tax, overheads transportation, labor charges for handling and testing at the site etc.
13. If the bid does not meet specification and other requirement the same will be rejected even in case of lowest bidder.
14. The bidders should visit the site before submitting their tenders to determine the exact nature and quantum of work and site condition.
15. No tender documents shall be issued on the date fixed for opening of the tenders.

Bids should be dropped in the sealed Tender Box kept in the Office of Deputy Chief Manager (Admn) at 4th Floor, State Bank of Pakistan, SBP BSC, Multan by 11.00 A.M., on 02nd December, 2015. Bids will be opened on the same day at 11.30 A.M., in the presence of Bidders who may like to be present.

Any attempt to influence or receipt of recommendations from any outsider shall disqualify such bidder. This notice is only an invitation to offer quotations and the Bank reserves the right to accept or reject any or all quotations at any time as per PPRA rules.
