ESSENTIAL WORKS TO PRESERVE UNDER CONSTRUCTION BUILDING <u>AT SIALKOT</u>

State Bank of Pakistan, SBPBSC (Bank) invites sealed Tenders from the civil Contractors/ Contracting firms who are enlisted with Pakistan Engineering Council at least in C-6 and above with specialization category CE-10.

Tender Documents can be obtained from the office of **The Chief Manager SBP BSC**, **Sialkot (Phone # 052-9250350 Ext 207)** on payment of **Rs.2000/**-(non-refundable) fees on submission of written request/application along with Demand Draft/Pay Order in the favor of **State Bank of Pakistan**. Bidding will be conducted using National competitive Single Stage Two Envelope procedure as specified in the Public Procurement Rule 36(b)-(PPRA-2004). Technical and financial proposals should be sealed in two separate envelopes and be placed in 3rd envelope. The name of the bidder and tender description (Name and technical or financial proposal) shall be clearly marked on all envelopes. Bids shall be evaluated on the basis of **Bid Evaluation Criteria** given in the tender documents. After the evaluation & approval of the Technical Proposals, Financial Proposals of the technically accepted bids shall be publicly opened at a time, date and venue, to be communicated to the qualified bidders in advance.

Bidder must submit copies of work orders and completion certificates of three (03) completed jobs of civil/ construction of similar nature works, costing at least Rs.10 million during last five (05) years. Bidder must submit valid Pakistan Engineering Council registration certificate and income tax registration certificate.

The Bidder must submit Earnest Money (refundable) equal to 2% of the total quoted amount payable in the shape of Bank Draft/Payment Order in favor of State Bank of Pakistan. The bid to be submitted in a sealed cover along with requisite earnest money duly signed & marked with the subject and dropped either personally or sent through Registered Post/Couriers so as to reach the office of the **PA to Chief Manager at old office building, state bank of Pakistan, Kutchery road, Sialkot** on or before **29**th **September 2015** till 03:00 PM. Technical Proposals shall be opened on the same place and date at 03:30PM in the presence of bidders or their representative who may like to attend the session. No tender shall be sold on the date fixed for opening of the tenders. In case of any unforeseen reason, public holiday, unrest or force majeure on the bid submission/ opening date, the tender shall be opened on the next working day at the same place and time.

Conditional, Incomplete tender & tender without or less than 2% Earnest Money as mentioned above and Bidder not fulfilling the above mentioned requirements shall be considered as non-responsive. Bidders are requested to give their best & final prices as no negotiations is allowed. This tender is only an invitation to offer and bank reserves the right to reject all tenders as per PPRA Rules. Further, personal canvassing or recommendations will disqualify the Bidder(s). Bid(s) not submitted on Bank's prescribed format/BOQ will also be considered as non-responsive.
