Sealed Bids are invited from the eligible firms/contractors for the above mentioned Services. Firms/Contractors must be (a) registered with income tax, sales tax departments as well as any other applicable tax departments, (b) must have five (5) years of general experience and at least 3 contracts of similar nature and complexity during last 3 years with contract value of Rs 0.9 million or more in operation and maintenance services of diesel generator sets, allied equipments and electrical services to the buildings as conveyed by supporting evidence such as work orders, completion certificates, engaged in providing similar services to well established public or private enterprises or multinational organizations, (c) never been blacklisted or failed to perform in any government or private organization. Complete details of scope of work and services are available in the tender documents.

The amount of Earnest Money/Bid Security for the above tender is 2% of the total bid amount (2% of total bid amount for 12 months), valid for 15 (fifteen) days beyond the bid validity date, payable in the form as specified in the Bidding Documents in favor of SBPBSC (Bank), Peshawar.

Tender documents can be obtained from State Bank of Pakistan, Banking Services Corporation, Bank, Saddar Road Peshawar during office hours on working days not later than **11th April, 2016** on payment of non-refundable tender fee of PKR 1,000/- (Rupees one thousand only) with written request/application on company's letter head.

If any clarification is required, a written query may be sent to the undersigned through registered courier, e-mail or fax, at least 5 (five) days prior to the date fixed for submission of bids. Bids should be dropped in the Tenders Drop Box kept in the office of the PA to Chief Manager, SBPBSC Peshawar on or before **12th April, 2016 till 3:00PM**. Technical Proposals shall be opened on the same day at **3:30PM** in presence of the bidders or their authorized representatives who may like to attend the session.

Financial Bids of technically qualified bidders shall be opened in presence of the bidders or their authorized representatives who may wish to attend the session at the time & venue communicated to the technically qualified bidders in advance. In case of any unforeseen reasons, unrest or force majeure on the bid submission/opening date, the tender shall be opened on the next working day at the same place and time. The bids must be valid for a minimum period of 90 (ninety) days from the date fixed for submission of the Bids. No bidding documents shall be sold on the date fixed for opening of the bids. Incomplete, conditional and bids without appropriate earnest money shall not be considered. The tender is only an invitation to offer and as per PPRA rules, Bank reserves the right to accept or reject these tenders.
