**SUPPLY OF MATERIAL FOR ENGINEERING STORE  
AT SBP BSC (BANK), PESHAWAR**

Sealed Tenders are invited from Suppliers/Contractors enlisted with Pak. P.W.D., Provincial P.W.Ds, M.E.S., State Bank of Pakistan or any multinational/well reputed organizations having at least 2 years experience of similar nature supply and registered with Sales/Income Tax Departments for supply of the subject material.

1. The amount of Earnest Money for the above tender is **2%** of the total bid amount payable in the form of Bank Draft/Payment Order in favor of the State Bank of Pakistan SBPBSC (Bank), Peshawar.
2. Tender Documents can be obtained from the **Engineering Division, 2<sup>nd</sup> Floor of SBPBSC (Bank), Peshawar** during office hours on working days but not later than **11<sup>th</sup> August, 2016** on payment of Rs.500/- (Rupees five hundred only) as tender fee (non-refundable) in the form of cash or Payment Order in favor of SBPBSC (Bank), Peshawar with written request/application on company's letter head. The applicant must have to provide documentary proof/evidence of the 2 years experience of similar works and copy of valid Sales Tax and Income Tax Registration Certificates while applying for issuance of the bidding documents.
3. Bidding will be conducted on the basis of National Competitive Bidding method under the provisions of Public Procurement Rule-36(a) Single Stage - One Envelope Procedure (PPRA Rules-2004).
4. Sealed tenders shall be dropped in the Tenders Drop Box kept in the **Chief Manager's Chamber, Mezzanine Floor, SBPBSC (Bank), Peshawar** on or before by or before the date fixed for submission of Bids i.e. **12<sup>th</sup> August, 2016** till **3.00 PM**. Bids shall be opened on the same date at **3:30 PM** in the presence of bidders or their authorized representatives who may like to be present.
5. Tender of a bidder shall be cancelled if the bidder is found blacklisted by State Bank or any Government/Semi Government organization at any stage during tendering process.
6. The bid of any bidder shall be declared non-responsive if he is found involved in litigation with any government or semi-government department.
7. In case of any unforeseen reasons, unrest or force majeure on the bid submission/opening date, the tender shall be opened on the next working day at the same place and time.
8. The Bids shall remain valid for a minimum period of **90** days from the date fixed for submission of the Bids.
9. Incomplete, conditional and tenders without appropriate earnest money shall not be considered.
10. These tenders are only invitation to offer and Bank does not bind itself to accept the lowest or any tender as per PPRA rules.
11. Personal canvassing, recommendation or unauthorized practices for getting the contract will also disqualify the bidder.
