TENDER NOTICE

Supply, Installation, Testing and Commissioning of Public Address System

1. State Bank of Pakistan, SBP-BSC (Bank), invites sealed bids for **“Supply, Installation, Testing and Commissioning of Public Address System at SBP BSC Karachi Office Banking Hall”**.
2. Bidding will be conducted under National Competitive Bidding pursuant to “Single stage two envelopes procedure” as per Rule 36(b) of Public Procurement Rules 2004 (PPR 2004) and is open to all eligible bidders as defined in the above Rules who meet the following minimum eligibility/criteria:
 - a. Bidder must be Manufacturer/Direct authorized distributor of OEM for the required item in Pakistan.
 - b. Registered with Income Tax and Sales Tax Department (Valid NTN and GST Certificate).
 - c. Documented experience of the Individual bidding firm completing at least three (03) assignments of a comparable scale during last three (03) years.
 - d. Annual turnover of at least Rs.5.0 million during any of the last three (03) years.
 - e. The interested bidders should have verifiable presence /support/branch offices in Karachi or any other city of the country.
 - f. The Firms/Bidders/Suppliers shall not be eligible to bid if ; (i) blacklisted by any Government/Semi Government organizations, (ii) failed to perform any of their previous contract with SBP/ any other Government/Semi Government organizations or (iii) in litigation with any of the Government/Semi Government organizations.
 - g. Undertaking that spare parts of the offered system will remain available for at-least 5 years from the date of delivery of equipment.
 - h. Delivery Period Max 08 weeks from the date of issuance of work order.
 - i. Completion time 12 weeks from the date of issuance of work order.
 - j. Warranty period 24 Months from the date of successful commissioning of the system.
 - k. Technical Literature and other details including manufacturer's Catalogue shall be submitted for the above.
 - l. Manufacturer must have 20 years of experience in manufacturing the Public Address equipment.
 - m. The bidder must have five years of experience in supply and providing support of Public Address system
 - n. The supplier should have professionally skilled/trained manpower to provide the after sale services, for example maintenance/repair etc
3. The bidders must quote only one type/model of equipment, meeting the technical specifications required by the Bank. Technical brochure containing detailed specifications of the said item should be provided with the bid.
4. The earnest money of the bid shall be equal to **2%** of the bid price which must be accompanied by Financial Proposal in sealed envelope, payable in the form of bank draft/pay order, drawn in favour of SBP Banking Services Corporation (Bank), Karachi. Conditional, incomplete or unsigned bid(s) submitted by the bidder/authorized nominee of the bidder will be rejected.
5. The rates quoted by the bidders should be **valid at least for period of (120) days** from the date of opening of bids.
6. Interested eligible bidders may obtain the bidding documents on submission of a written application on the letter head of the firm on the address given below upon payment of Rs.1000/- (non-refundable) in the shape of bank draft/pay order. If the bidding documents are requested by post/courier then non-refundable amount of Pak Rs.1500/- will be charged. 7. Bids must be delivered to the address below on or before **Tuesday, June 07, 2016 11:00 A.M** and will be opened on the same day in the presence of bidders/their representatives who may choose to attend the proceedings on **Tuesday, June 07, 2016 11:30 A.M** in the Meeting Room, 2nd Floor, Main Building, State Bank of Pakistan, I.I Chundrigar Road, Karachi – Pakistan.
8. The Financial Proposals of only those firms will be opened who shall be declared technically qualified by an independent evaluation committee particularly constituted for the purpose.
9. The competent authority reserves the right to reject all bids or proposals at any time prior to the acceptance of a bid or proposal under Section 33 of PPRA Rules.
