Sealed Bids are invited from the eligible firms/ contractors for the above mentioned Services. Firms/ Contractors must be **(a)** registered with income tax department **(b)** must have at least **three (3)** years experience of provision of services for building maintenance works, engaged in providing similar services to well-established public or private enterprises or multinational organizations, **(c)** never been blacklisted or failed to perform in any government or private organization. The amount of Earnest Money/ Bid Security for the above tenders is 2% of the total bid amount (2% of total bid amount for 12 months), valid for 15 (fifteen) days beyond the bid validity date, payable in the form as specified in the Bidding Documents in favor of State Bank of Pakistan.

Bids should be dropped in the Tenders Drop Box kept in the office of the Chief Manager, SBP BSC Peshawar on or before 5<sup>th</sup> May, 2016 till 3:00 PM Technical Proposals shall be opened on the same day at 3:30 PM in the presence of the Bidders or their authorized representatives who may like to attend the session.

Financial Bids of technically qualified bidders shall be opened in the presence of the Bidders or their authorized representatives who may wish to attend the session, at the time & venue communicated to the technically qualified bidders in advance. In case of any unforeseen reasons, unrest or force majeure on the bid submission/opening date, the tender shall be opened on the next working day at the same place and time. The Bids must be valid for a minimum period of 90 (ninety) days from the date fixed for submission of the Bids. No bidding document shall be sold on the date fixed for opening of the bids. Incomplete, conditional and bids without appropriate earnest money shall not be considered.
