TENDER NOTICE

**INVITATION OF BIDS FOR SUPPLY OF STATIONERY
ITEMS AND COMPUTER CONSUMABLES FOR 2016-17**

1. State Bank of Pakistan BSC (Bank) Hyderabad invites sealed bids from eligible bidders for supply of Stationery items and Computer Consumables as per quantity and specification given in the bidding documents.
2. Bidding will be conducted under National Competitive Bidding pursuant to 'Single Stage – single envelope procedure' as per Rule 36(a) of Public Procurement Rules 2004 and is open to all eligible bidders as define in the PPRA Rules 2004 who meet the following minimum eligibility/qualification criteria:
 - i. Bidder should have documented track of completing similar assignments. Evidence to be provided along with bid.
 - ii. Registered with Income Tax and Sales Tax Departments. Sindh govt. taxes are also applicable.

The bidders are requested to give their best and final prices. The rates quoted must remain valid for a period of 90 days after opening of bids.

3. Interested eligible bidders may obtain bidding documents (BOQs, specifications and terms and conditions) on payment of a non-refundable amount of Rs.500/- in cash or through Bank Draft/Pay Order drawn in favour of SBP BSC (Bank) Hyderabad. The tender documents can be obtained from General Services Unit, 1st floor SBP BSC Hyderabad from **9.00 a.m. to 5.30 p.m.** on any working day but not later than 23-09-2016. If the bidding documents are requested by post then non refundable fee of **PKR 1000/-** will be charged. 4. All bids must be accompanied by a bid security of 2% in the shape of Bank Draft/Pay Order of the bid value favouring SBP BSC (Bank) Hyderabad.
5. Conditional, incomplete and bids without earnest money of 2% will not be considered.
6. Bids not meeting the requirements as per Bid Evaluation Criteria (BEC) shall be rejected and such bidders shall be declared disqualified
7. Sealed Tenders / Bids should be dropped in the Tenders Drop Box kept at the Chamber of Chief Manager on / or before 11.00 **a.m. on 26.09.2016.** Bids shall be open on the same date at 11.30 a.m. in the presence of bidders or their authorized representatives (who may like to attend).
