Bidding will be conducted under National Competitive Bidding Procedure as per the provisions of Public Procurement Rules-36(a) *single stage, single envelope* procedure-(PPRA-2004). Bids should be dropped in the Tenders Drop Box kept in the office of the PA to Director Engineering, 1st Floor, SBP BSC Bolton Market Building, M.A Jinnah Road Karachi, by or before the time mentioned in the above table. The Bids shall be opened as per the given schedule in the presence of the Bidders or their authorized representatives who may like to attend the session. In case of any unforeseen reasons, unrest or force majeure on the bid submission/opening date, the tender shall be opened on the next working day at the same place and time.

The Bids shall remain valid for a minimum period of **60** days from the date fixed for submission of the Bids. Bid of any bidder shall be cancelled if the bidder is found blacklisted by any organization at any stage during tendering process or execution of the Contract.
