- 1. Tender shall be submitted in accordance with the Schedule of Prices, Specifications and other provisions of the tender documents provided to the intended bidders. Bids shall be evaluated on the basis of evaluation criteria given in the tender documents.
- 2. Contractors/contracting firms or companies are required to have minimum 10 years experience in Operation and Maintenance of Screw type Chiller Based HVAC systems having capacities not less than 400 TR of reputed/multinational organizations and have their own workshop & store for related spare parts chillers and allied Equipment to keep above plant operational/uninterrupted.
- 3. Bidding shall be conducted using the National Competitive Bidding Procedure specified in the PPRA Rules 2004 and is opened to all eligible bidders that meet the minimum qualification criteria mentioned in the tender documents.
- 4. Technical & Financial Bids shall be valid for a minimum of 90 days from date of submission of Bid.
- 5. Prescribed tender documents can be obtained from the Office of the under signed during office hours up to 16th November, 2015 at Engineering Site Office, Ground Floor Main Building, I.I. Chundrigar Road, Karachi on payment as mentioned in the above schedule against Cash/Pay Order / Demand Draft (non-refundable) in favor of State Bank of Pakistan & on production of Request Letter on Company's Letter Head and copy of Sales Tax Certificate, Income Tax Certificate, and Company's Profile on any working day/timings and 03copies of work orders of similar nature of works.
- 6. No Tender Documents shall be sold on the date fixed for opening of the Tender.
- 7. The Earnest Money should not less be than 2% of the total quoted amount in shape as mentioned in the tender documents should be submitted with the tender (cash will not be accepted).
- 8. Incomplete, conditional and tenders without required amount of earnest money in the specified form/format shall be rejected.
- 9. The technical and financial proposals should be sealed separately and be placed in 3rd envelope.
- 10. The name of the bidder and tender description (Name and technical or financial bid) shall be clearly marked on all envelopes. Tender should be dropped in tender box kept in the office of the PA to Director Engineering at 1st floor SBP Bolton Market Building, M.A. Jinnah Road, Karachi as per the detail mentioned in the above table.
- 11. This tender is only an invitation to offer and the Bank reserves the right to reject all tenders any time as per PPRA Rules. Whereas, the work will be awarded to the successful/responsive lowest evaluated bidder on lot wise basis.
