- Prescribed tender documents can be obtained from the Office of the undersigned at Engineering Office, First Floor SBP Boulton Market, MA Jinnah Road, Karachi and Office of the Executive Engineer SBP BSC Sialkot during office hours up to 30<sup>th</sup> March, 2016 on payment of Rs. 1000/- Cash/Pay Order (non-refundable) in favor of State Bank of Pakistan & on production of Request Letter on Company's Letter Head along with copies of 03 work orders of similar nature of works issued from clients, copies of Tax registration Certificates and Company's Profile on any working day/timings.
- The Earnest Money should not be less than 2% of the total quoted amount in shape of pay order (cash will not be accepted) and should be enclosed with the Financial Proposal of tender. Further, tenders without earnest money in the specified form/format, incomplete, optional and conditional bids shall be rejected.
- 3. Bidders must have a documented track record of completing at least 3 similar assignments of same capacity and quantity or above, during last 3 (three) years, of similar functional / technical characteristics and of a comparable scale.
- 4. The Bid shall comprise a single package containing two separate envelopes. Each envelope shall contain separately the "Financial Proposal" and the "Technical Proposal", and marked clearly as such. Technical and Financial proposals should each be sealed, and placed in 3<sup>rd</sup> envelope.
- 5. The name of the bidder, tender description and whether Technical or Financial proposal shall be clearly marked on all envelopes. Tender should be dropped off in the tender box located in the office of the PA to Director Engineering at same location as mentioned above
- 6. In case the tender is not opened on the scheduled date due to any force majeure then the same shall be opened on the next working day at the same time and place. Further details are provided in the tender documents.
- 7. Any clarification required may be sent by E-mail / Courier to us reaching at least Five (05) days prior to the Bid opening date after which no further clarifications/queries shall be entertained. All replies to the queries shall be considered part of tender documents and should be signed and submitted along with the technical proposal.
