Bidding will be conducted under National Competitive Bidding pursuant to ‘Single stage two envelopes procedure’ as per **Rule 36(b)** of Public Procurement Rules 2004 (PPR 2004) and is open to all eligible Bidders as defined in the PPR 2004 that meet the following minimum eligibility/qualification criteria:

- Bidder must be registered with Income and Sales Tax Department and also appear on Active Taxpayers List (ATL) of FBR.
- Bidders must be a Manufacturer (OEM) or an authorized Agent /Partner of the manufacturer for last 03 (three) consecutive years.
- Bidders must be authorized by their OEM(s) specifically for this procurement.
- The offered product(s) must have been installed at minimum 3 verifiable organizations in Pakistan during last 3 years.
- Bidder must have technical strength of at least 2(Two) OEM Certified and Trained Engineers above entry/associate level.
- Bidder must have Annual Sales Volume/Gross Turnover of at least 3 million rupees, in any of last 03(three) years;

Bidders have to submit bids for the Complete Package, evaluation of the bids and award of contract will be done for the whole package.
