1. The SBP Banking Services Corporation (BSC) intends to procure Steel Racks for FEOD-HOK, SBPBSC. Sealed bids are invited from all eligible bidders that meet the following eligibility criteria:
 - a) *Bidder must be Manufacturer / authorized agent of the manufacturer for the required item in Pakistan;*
 - b) *Bidder must have documented experience of three (3) assignments of supplies of quoted steel cupboards in Pakistan during last three (3) years;*
 - c) *Bidder must have Annual Sales Volume/Gross Turnover of at least Rs.5 million in any of last three (3) years;*
 - d) *Bidder must have support/branch offices in Karachi, to provide technical support.*
 - e) *Bidder must be registered with Income and Sales Tax Department and also appear on Active Taxpayers List (ATL) of FBR.*
 - f) *Bidder must furnish an Affidavit to ensure that he is not Black Listed from any Governmental/ Semi Government organizations in Pakistan.*

Bidding documents containing detailed terms and conditions, etc. are available for the interested bidders from the address given below on submission of a written application upon payment of a non-refundable fee of **Rs.1,000/-** (one thousand only) through Bank Draft/Pay Order drawn in favor of SBP BSC (Bank). If the bidding documents are requested by post courier then non-refundable fee of Pak **Rs.1,500/-** will be charged
3. The bids, prepared in accordance with the instructions in the bidding documents, must reach at office of the undersigned on or before **Thursday February 2nd, 2017 11:00 am**. Bids will be opened on same day at **11:30 am**, at Learning Resource Centre, State Bank of Pakistan, I.I Chandigarh Road, Karachi –Pakistan.
