Sealed Tenders/Bids should be dropped in the Tender Box kept at the office of the Currency Officer 3<sup>rd</sup> Floor, State Bank of Pakistan SBP-BSC, 56, Sharah-e-Quaid-e-Azam, Lahore on/or before 11:00 a.m. <u>29-01-2018</u>. Bids shall be opened on the same date at 11:30 a.m in the presence of Bidders or their authorized representatives (who may like to attend). No documents will be issued on the date fixed for opening of tenders.

## **Terms & Conditions:**

- 1. The bidder must be registered with tax authorities.
- 2. Government minimum wages rule should be followed.
- 3. The bidder must be compliant of all prevailing laws/statutes of Pakistan.
- 4. The successful bidder shall execute agreement with the Bank on the prescribed format before award of work.
- 5. Complete CV of the concerned staff, supported by relevant documents, is required to be submitted along with quotation.
- 6. Contractor will be responsible for obtaining police or other authorized agencies clearance / verification for all the employees providing the services.
- 7. Payment would be made on monthly basis (No. of hours worked) after deduction of applicable taxes.
- 8. No overtime will be paid on outstation duty.
- 9. Rates should be valid for 90 days and should include all applicable taxes.
- 10. Incomplete and conditional quotation shall be rejected.
- 11. Earnest money @2% (in the shape of payment order/ bank draft) of quoted amount (2640 x quoted hourly rate x 2 x 2) should be attached with the quotation.
- 12. Quoted amount should be inclusive of salaries, social benefits, compensations, insurance, applicable taxes, all overheads & profit etc. No other payment shall be made by SBP BSC on any grounds whatsoever except the above quoted hourly rates.
