CONSTRUCTION OF BALANCE WORKS OF NEW OFFICE BUILDING AT SIALKOT

State Bank of Pakistan Banking Services Corporation (Bank), Kutchehry Road, Sialkot Office invites sealed bids from the eligible bidders registered with Income Tax and Sales Tax Departments and who are on Active Taxpayers List of the Federal Board of Revenue (Sales Tax and Income Tax) and having valid PEC registration in C-1 or above with specialization codes CE10, ME-01 and EE-04 for "Construction of Balance Works of New Office Building at Sialkot". The bidders must be registered with Punjab Revenue Authority (PRA), if not registered with PRA, then upon payment 100% deduction of tax will be made as per applicable laws.

Please collect Bidding documents, containing detailed terms and conditions, etc. from the Office of the Assistant Chief Manager, Engineering Unit, State Bank of Pakistan, SBP BSC Sialkot Office (Phone: 052-9250360, Ext: 209). The firms are required to submit their application on letterhead for issuance of bidding documents along with Pay order / demand draft of Rs. 20,000/- (Non-Refundable) for above work drawn in favor of the State Bank of Pakistan Banking Service Corporation as Bidding Documents fee. The bidding will be conducted under National Competitive Bidding Procedure specified in the Public Procurement Rules 2004 as per Rule-36(b), under Single Stage and Two Envelopes procedure.
- 3. The firms are strictly advised to visit the project site. The site can be visited on 19th and 20th Dec, 2019 at 11:00 AM. The site can also be visited after said dates at the convenience of dealing officer available on email at <u>muhammad.ibrar@sbp.org.pk</u>. Any prospective bidder requiring any clarification(s) in respect of the Bidding Documents may notify the Employer in writing 28 days prior to the deadline for submission of bids.

All bids must be submitted in accordance with the instructions in the bidding documents, must be dropped in the tender box kept in the Office of Chief Manager, State Bank of Pakistan SBP BSC, Sialkot on or before 24th Jan, 2020 till <u>11:00 AM</u> along with Bid Security of 2% of total Bid Price (Bid security should be in Financial bid). Bids will be opened on the same day at same venue at <u>11:30 AM</u>. Incase opening date is falling on a public holiday, the bid will be opened on next working day at the same time and venue.
