- 1. This Invitation to Bids follows the Procurement Advertisement (PA) No. ENGG./013322 /IPBC/2022-23 for the procurement of "SUPPLY, INSTALLATION, TESTING AND COMMISSIONING OF IP BASED CAMERAS AT CASH COUNTERS OF SBP BANKING SERVICES CORPORATION, MUZAFFARABAD OFFICE".
- 2. The SBP Banking Services Corporation (SBP BSC) has reserved the funds for the procurement planned during the financial year 2022-23. It is intended that part of the proceeds of the fund will be used to cover eligible payment under the contract for the procurement.
- **3.** SBP B S C now invites sealed bids from eligible Suppliers to acquire IP Based Cameras that meet the following eligibility criteria:
  - a. Bidder must be an Original Equipment Manufacturer (OEM) or a direct authorized agent/dealer or supplier of the OEM of the offered camera models in Pakistan;
  - b. The offered product(s) must have been installed at minimum 03 verifiable organizations in Pakistan during the last 5 (five) years; (at total cost of 1M or above for each project)
  - *c.* Bidder must have Minimum Liquid assets of Rs. 1 Million at any one instance in three months period prior to publication of ITB;
  - d. Bidder must be registered with Income Tax and Sales Tax Department and must appear on the Active Tax Payers List of FBR/AJK Council.
  - e. Bidder must not be blacklisted or in breach of performance with SBP or any Organization(s).
- **4.** The bidding shall be conducted in line with the Single Stage Two Envelope Procedure of the Public Procurement Rules 2004 and any Regulations, Regulatory Guides, Procurement Guidelines or Instructions issued by the Authority (from time to time) and is open to all potential bidders.
- 5. All bids must be accompanied by a Bid Security in an acceptable form amounting to PKR 24,000/-.
- 6. Bidding Documents containing detailed Description of Services, Terms & Conditions, etc. can be obtained free of cost via email request at hassan.muhammad@sbp.org.pk or can be downloaded directly from the SBP website www.sbp.org.pk.
- 7. The bids, prepared in accordance with the instructions in the bidding documents, properly filled in and enclosed in sealed envelope(s), must be delivered at the PA to Chief Manager at 1<sup>st</sup> Floor, SBP Banking Services Corporation, Muzaffarabad on or before 28-03-2023 @ 03:00 PM. ## Section II. Instructions to Bidders (ITBs)

	<u>A. Introduction</u>		
1	. Scope of Application	1.1	The Procuring Agency (PA), as indicated in the <b>Bid Data Sheet</b> ( <b>BDS</b> ) invites Bids "SUPPLY, INSTALLATION, TESTING AND COMMISSIONING OF IP BASED CAMERAS AT CASH COUNTERS OF SBP BANKING SERVICES CORPORATION, MUZAFFARABAD OFFICE" as specified in the BDS and Section V - Technical Specifications & Schedule of Requirements. The successful Bidders will be expected to supply and install the equipment within the specified period and timeline(s) as stated in the BDS.
2	Sources of Funds	2.1	Source of funds is referred in Clause-2 of Invitation to Bids.
3	Eligible Bidders	3.1	A Bidder may be natural person, company or firm or public or semi-public agency of Pakistan or of any foreign country, or any combination of them with a formal existing agreement (on Judicial Papers) in the form of a joint venture, consortium, or association. In the case of a joint venture, consortium, or association, all members shall be jointly and severally liable for the execution of the Contract in accordance with the terms and conditions of the Contract. The joint venture, consortium, or association shall nominate a Lead Member as nominated in the BDS, who shall have the authority to conduct all business for and on behalf of any and all the members of the joint venture, consortium, or association during the Bidding process, and in case of award of contract, during the execution of contract. The appointment of Lead Member in the joint venture, consortium, or association shall be confirmed by submission of a valid Power
		3.3	of Attorney to the Procuring Agency. Verifiable copy of the agreement that forms a joint venture, consortium or association shall be required to be submitted as part of the Bid.
		3.4	Any bid submitted by the joint venture, consortium or association shall indicate the part of proposed contract to be performed by each party and each party shall be evaluated (or post qualified if required) with respect to its contribution only, and the responsibilities of each party shall not be substantially altered without prior written approval of the Procuring Agency and in line with any instructions issued by the Authority.
		3.5	The invitation for Bids is open to all prospective supplier, manufacturers or authorized agents/dealers subject to any provisions of incorporation or licensing by the respective national incorporating agency or statutory body established for that particular trade or business.



3.6	Foreign Bidders must be locally registered with the appropriate national incorporating body or the statutory body, before participating in the national/international competitive tendering with the exception of such procurements made by the foreign missions of Pakistan. For such purpose the bidder must have to initiate the registration process before the bid submission and the necessary evidence shall be submitted to the procuring agency along with their bid, however, the final award will be subject to the complete registration process.
3.7	A Bidder shall not have a conflict of interest. All Bidders found to have a conflict of interest shall be disqualified. A Bidder may be considered to have a conflict of interest with one or more parties in this Bidding process, if they:
	<ul> <li>a. are associated or have been associated in the past, directly or indirectly with a firm or any of its affiliates which have been engaged by the Procuring Agency to provide consulting services for the preparation of the design, specifications and other documents to be used for the procurement of goods and related services to be procured under this Invitation for Bids.</li> <li>b. have controlling shareholders in common; or</li> <li>c. receive or have received any direct or indirect subsidy from any of them; or</li> <li>d. have the same legal representative for purposes of this Bid; or</li> <li>e. have a relationship with each other, directly or through common third parties, that puts them in a position to have access to information about or influence on the Bid of another Bidder, or influence the decisions of the Procuring Agency regarding this Bidding process; or</li> <li>f. Submit more than one Bid in this Bidding process.</li> </ul>
3.8	A Bidder may be ineligible if –
5.0	a. he is declared bankrupt or, in the case of company or firm, insolvent;
	b. payments in favor of the Bidder is suspended in accordance with the judgment of a court of law other than a judgment declaring bankruptcy and resulting (in accordance with the national laws) in the total or partial loss of the right to administer and dispose of its property;
	c. legal proceedings are instituted against such Bidder involving an order suspending payments and which may result, in accordance with the national laws, in a declaration of bankruptcy or in any other situation entailing the total or partial loss of the right to administer and dispose of the property;

However, Procuring Agency shall place both the pdf and same editable version to facilitate the bidder for filling the forms.
		7.4	The Bidder is expected to examine all instructions, forms, terms and specifications in the Bidding Documents. Failure to furnish all

		8.2	The Procuring Agency will within three (3) working days after receiving the request for clarification, respond in writing or in electronic form to any request for clarification provided that such request is received not later than three (03) days prior to the deadline for the submission of Bids as prescribed in <b>ITB 23.1.</b> However, this clause shall not apply in case of alternate methods of Procurement.
		8.3	Copies of the Procuring Agency's response will be forwarded to all identified Prospective Bidders through an identified source of communication, including a description of the inquiry, but without identifying its source.






