Scope of Application	1.1	The Procuring Agency (PA), as indicated in the <b>Bid Data Sheet</b> ( <b>BDS</b> ) invites Bids for the equipment and related services as specified in the BDS and Section V - Technical Specifications & Schedule of Requirements. The successful Bidders will be expected to supply and install the equipment within the specified period and timeline(s) as stated in the BDS.
2.	Sources of Funds	2.1	Source of funds is referred in Clause-2 of Invitation to Bids.
3.	Eligible Bidders	3.1	A Bidder may be natural person, company or firm or public or semi-public agency of Pakistan or of any foreign country, or any combination of them with a formal existing agreement (on Judicial Papers) in the form of a joint venture, consortium, or association. In the case of a joint venture, consortium, or association, all members shall be jointly and severally liable for the execution of the Contract in accordance with the terms and conditions of the Contract.
