## SECTION I – INSTRUCTIONS TO BIDDERS

<b>A. Introduction</b>	
<b>1. Scope of Bid</b>	<p>1.1. <b>SBP Banking Services Corporation</b> having its principal place of business as defined in Bid Data Sheet, (hereinafter called “<b>SBP BSC</b>”) invites Bids for the Services summarized in the Bid Data Sheet (<b>BDS</b>) (hereinafter referred to as “<b>the Services</b>”), at the Buildings and other areas specified in the <b>BDS</b> (hereinafter referred to as Premises).</p> <p>1.2. Bidders must quote for the complete scope of Services. Any Bid covering partial scope of Services will be declared non-responsive.</p> <p>1.3. The procurement title, reference number, method and procedure are specified in the <b>BDS</b>.</p>
<b>2. Eligible Bidders</b>	<p>2.1. Except as provided in Instructions to Bidders <b>Clauses 2.3, 2.4 and 2.5</b>, this bidding process is open to all Bidders who meet the qualification criteria given in Bidding Documents.</p> <p>2.2. Joint Ventures and Consortiums shall not be permitted to submit the bid.</p> <p>2.3. Bidder already engaged by the SBP BSC for providing consultancy services related to the above procurement (if applicable) will not be eligible for bidding.</p> <p>2.4. A Bidder declared ineligible for corrupt and fraudulent practices under <b>Rule 19 of Public Procurement Rules-2004 (PPR-2004)</b>, shall not be permitted to submit the bid. The Bidder must not be blacklisted by any Federal or Provincial Government Department, National Counter Terrorism Authority (NACTA), Agency, Organization, or Autonomous Body anywhere in Pakistan.</p> <p>2.5. A Bidder who has been declared blacklisted or debarred by a foreign country, international organization, or other foreign institutions shall be treated as blacklisted and debarred from participating. Any Bidder who has violated the law of land of any country and recorded in any sanction list will not be eligible to participate in the bidding/procurement process.</p> <p>2.6. Bidders shall provide evidence of their continued eligibility satisfactory to the SBP BSC, as the SBP BSC shall reasonably request.</p> <p>2.7. Bidder must meet all the qualification criteria as defined in Bidding Documents.</p>
<b>3. Qualification of the Bidder</b>	<p>3.1. All Bidders shall provide, Form of Bid and Qualification Information, as required in <b>BDS</b>.</p>

	3.2. To qualify for the award of the Contract, Bidders must meet the mandatory evaluation criteria, as specified in the Bidding Documents.
<b>4. One Bid per Bidder</b>	4.1. Each Bidder shall submit only one Bid individually. 4.2. A Bidder who submits or participates in more than one bid will be disqualified.
<b>5. Cost of Bidding</b>	5.1. The Bidder shall bear all costs associated with the preparation and submission of its bid, and the SBP BSC in no case be held responsible or liable for those costs, regardless of the conduct or outcome of the bidding process.

<b>B. Bidding Documents</b>	
<b>6. Content of Bidding Documents</b>	<p>6.1. The contents of the Bidding Documents subscribe to <b>Rule 23 of PPR-2004</b> are as given below. These should be read in conjunction with any addendum issued under <b>ITB Clause 8</b>:</p> <ul style="list-style-type: none"> <li>i. Invitation to Bid</li> <li>ii. Instructions to Bidders (<b>ITB</b>)</li> <li>iii. Bid Data Sheet (<b>BDS</b>)</li> <li>iv. Form of Bid</li> <li>v. Form of Contract</li> <li>vi. General Conditions of Contract (<b>GCC</b>)</li> <li>vii. Special Conditions of Contract (<b>SCC</b>)</li> <li>viii. Bill of Quantities/Description of Services</li> <li>ix. Bid Evaluation Criteria</li> <li>x. Format of Security Forms</li> </ul> <p>6.2. Bidders are expected to examine all instructions, forms, terms, specifications, and other information in the Bidding Documents.</p> <p>6.3. Failure to furnish all information required by the Bidding Documents or to submit a bid not substantially responsive to the Bidding Documents in every respect will be at the Bidder's risk and may result in the rejection of its bid.</p>
<b>7. Clarification of Bidding Documents and Pre-bid Meeting</b>	<p>7.1. A prospective Bidder requiring any clarification of the Bidding Documents may approach SBP BSC in writing at the given address and by one of the means indicated in the <b>BDS</b>. SBP BSC will respond in writing to any request for clarification of the Bidding Documents that it receives no later than <b>seven (07) days</b> before the deadline of submission of bids. Copies of the SBP BSC's response (including an explanation of the query but not identifying its source) will be sent to all prospective Bidders that received the Bidding Documents from the SBP BSC</p> <p>7.2. Under the provision of <b>Rule 48 of PPR-2004</b>, if a Bidder feels that any provision in the documents is contrary to the provisions of <b>Public Procurement Rules 2004 (Rules)</b>, such issue should be raised as soon as possible. Any party may file its written complaint</p>



<b>B. Bidding Documents</b>	
	<p>against the eligibility parameters, evaluation criteria, or any other terms and conditions prescribed in the Bidding Documents, if found contrary to the provisions of the <b>Rules</b>, the same shall be addressed by the <u><a href="#">Grievance Redressal Committee (GRC)</a></u> constituted under <b>Rule 48 of the PPR-2004</b> well before the Bid submission deadline.</p> <p>7.3. As specified in the <b>BDS</b>, SBP BSC will organize and Bidders are welcome to attend a Pre-bid meeting at the time and place indicated in the <b>BDS</b>. The purpose of the meeting will be to clarify issues and answer questions on any matter that may be raised at this stage, with particular attention to issues related to the Technical Requirements. Minutes of the meeting, including the questions raised and responses given, together with any responses prepared after the meeting, will be transmitted without delay to all those that received the Bidding Documents from the SBP BSC. Any modification to the Bidding Documents listed in <b>ITB Clause 6.1</b>, which may become necessary as a result of the pre-bid meeting, shall be made by the SBP BSC by issuing an Addendum under <b>ITB Clause 8</b>.</p>
<b>8. Amendment of Bidding Documents</b>	<p>8.1. At any time before the deadline for submission of bids, SBP BSC, for any reason, either at its initiative or in response to a clarification requested by a prospective Bidder, amend the Bidding Documents. Such amendments shall take precedence over the existing document.</p> <p>8.2. Any addendum issued including the notice of any extension of deadline shall be part of the Bidding Documents pursuant to <b>ITB 8.1</b> and shall be communicated in writing to all the Bidders who have obtained the Bidding Documents from SBP BSC. SBP BSC shall promptly publish the Addendum at the SBP website (<a href="http://www.sbp.org.pk">www.sbp.org.pk</a>).</p> <p>8.3. Provided that the Bidder who had either already submitted their bid or handed over the bid to the courier prior to the issuance of any such addendum shall have the right to withdraw his already filed bid and submit the revised bid prior to the original or extended bid submission deadline.</p> <p>8.4. The addendum will be binding on Bidders. It will be assumed that the amendments contained in such Addendum has been taken into account by the Bidder in its bid.</p> <p>8.5. To provide prospective Bidders reasonable time to take the amendments into account in preparing their bids, SBP BSC may, at its discretion, extend the deadline for the submission of bids consistent with the provision of <b>Rule 27 of PPR-2004</b>.</p>





<b>C. Preparation of Bids</b>	
<b>9. Language of Bid</b>	9.1. The bid prepared by the Bidder and all correspondence and documents relating to the Bid, exchanged by the Bidder and SBP BSC shall be written in the English or Urdu language; provided that any printed literature furnished by the Bidder in another language as long as accompanied by an English or Urdu translation of its pertinent passages in which case, for purposes of interpretation of the Bid, the English or Urdu translation shall govern the relation between the parties.
<b>10. Documents Comprising the Bid</b>	10.1. The bid submitted by the Bidder shall comprise the following: <ul style="list-style-type: none"> <li>i. Forms for Technical Proposal under <b>Section III</b></li> <li>ii. Documents related to Minimum Eligibility/ Qualification Criteria under <b>Section IV</b></li> <li>iii. Forms for Financial Proposal under <b>Section V.</b></li> <li>iv. Bidding Documents (in original) duly signed and stamped on each page / sheet.</li> <li>v. Bid Security in original</li> <li>vi. Power of Attorney in accordance with the <b>Clause 15 of ITB.</b></li> <li>vii. Any other materials/ services required to be completed and submitted by Bidders, as specified in the Bid Data Sheet.</li> </ul>
<b>11. Bid Prices</b>	11.1. The Bidder shall quote rates and prices for all items of Services described in the scope of services, and as listed in the Price Schedule. Items for which no rate or price is entered by the Bidder will not be paid for by the SBP BSC when the contract is executed and shall be deemed covered by other rates and prices in the Activity Schedule.  11.2. All duties, indirect taxes, liabilities including overheads, transportation charges etc. and other levies payable by the Bidder under the Contract, or for any other cause shall be included in the total Bid price submitted by the Bidder. Any additional tax, levies, duties, or modification in the existing rates of tax and other applicable laws imposed during the pendency of this contract shall be adjusted in the contract price by both parties. The exemption in Taxes will only be allowed against an Exemption Certificate issued by the respective Tax Authorities.  11.3. If provided for in the Bidding Data Sheet, the rates and prices quoted by the Bidder shall be subject to adjustment during the performance of the Contract in accordance with and the provisions of the General Conditions of Contract and/or Special Conditions of Contract.
<b>12. Currencies of Bid and Payment</b>	12.1. The price shall be quoted by the Bidder in Pak Rupees and the payments to be made by SBP BSC would be in Pak Rupees.
<b>13. Bid Validity</b>	13.1. Bids shall remain valid for a period specified in the <b>BDS.</b>  13.2. In exceptional circumstances, SBP BSC may request the Bidders to extend the bid validity period for an additional period. The request

	and the Bidders' responses shall be made in writing by letter or email. A Bidder may refuse the request without forfeiting the Bid Security. A Bidder agreeing to the request will not be required or permitted to otherwise modify the Bid, but will be required to extend the validity of Bid Security for the period of extension, and in compliance with <b>ITB Clause 14</b> in all respects.
<b>14. Bid Security</b>	<p>14.1. The bid security shall be denominated in the currency of the bid:</p> <ol style="list-style-type: none"> <li>i. at the Bidder's option, be in the form of either Pay Order/demand draft/call deposit or an unconditional Bank Guarantee from a Scheduled Bank;</li> <li>ii. be substantially in accordance with one of the forms of bid security included in bidding documents or other form approved by the SBP BSC before bid submission;</li> <li>iii. be payable promptly upon written demand by the SBP BSC;</li> <li>iv. be submitted in its original form; copies will not be accepted;</li> <li>v. In the case of Bank Guarantee, it shall remain valid for at least <b>28 days</b> beyond the original validity period of bids, or at least <b>28 days</b> beyond any extended period of bid validity subsequently requested under <b>ITB Clause 13.2</b>.</li> <li>vi. bids submitted with insufficient bid security will be rejected.</li> <li>vii. bid security of unsuccessful Bidders will be released/ returned after the conclusion of the procurement process, as soon as possible, upon receipt of the nomination to receive the instrument.</li> <li>viii. the most advantageous Bidder's bid security will be released/ returned upon the submission of performance security.</li> </ol> <p>14.2. The bid security may be forfeited:</p> <ol style="list-style-type: none"> <li>i. If a Bidder withdraws its bid during the period of bid validity; or</li> <li>ii. If a Bidder does not accept the correction of his Bid Price, pursuant to <b>Sub-Clause 24</b> of <b>ITB</b> hereof;</li> <li>iii. In case of most advantageous Bidder, if he fails to: <ol style="list-style-type: none"> <li>a) Furnish the required Performance Guarantee in accordance with <b>Clause 32 of ITB</b>, or</li> <li>b) Sign the Agreement, in accordance with <b>Sub-Clauses 30.2 &amp; 30.3 of ITB</b></li> </ol> </li> </ol>
<b>15. Format and Signing of Bid</b>	15.1. The Bidder shall prepare one original and at least one copy of the bid specified in the <b>BDS</b> , clearly marking each one as " <b>ORIGINAL BID</b> " and " <b>COPY NO. 1.</b> " In the event of any discrepancy between them, the originally submitted hardcopy shall prevail.



<b>C. Preparation of Bids</b>	
	<p>15.2. The original and all copies of the bid shall be typed or written in permanent ink and shall be signed by a person or persons duly authorized to sign (in the case of copies, Photostats are also acceptable). This shall be indicated by submitting a written Power of Attorney authorizing the signatory of the Bidder to act for and on behalf of the Bidder. The authorization must be in writing and included in the bid under <b>ITB Clause 10.1</b>. The name and position held by each person signing the authorization must be typed or printed below the signature. The person or persons signing the bid shall put signatures on all pages of the bid, except for the un-amended printed literature. All Schedules to Bid are to be properly completed and signed.</p> <p>15.3. No alteration is to be made in the Form of Bid except in filling up the blanks as directed. If any alteration is made in the Form of Bid or any other part of Bidding Documents, or if these instructions be not fully complied with, the bid may be rejected.</p> <p>15.4. In accordance with <b>ITB Clause-16</b>, Bids shall be sealed in an envelope addressed to SBP BSC at the address provided in the Bid Data Sheet, with description of the contract and a warning regarding not to open before the specified date and time. Name and address of the Bidder must also be marked on the envelope at the appropriate place.</p> <p>15.5. The bid shall contain no interlineations, erasures, or overwriting, except to correct errors made by the Bidder, in which case such corrections shall be signed by the person or persons signing the bid.</p>

<b>D. Submission of Bids</b>	
<b>16. Sealing and Marking of Bids</b>	<p>16.1. The Bidder shall seal the original and each copy of the bid in separate envelopes, duly marking the envelopes as <b>“ORIGINAL BID”</b> and <b>“COPY NO. [Number].”</b> The envelopes shall then be sealed in an outer envelope. The inner and outer envelopes shall be addressed to the SBP BSC at the address given in the <b>BDS</b>, and carry the statement <b>“DO NOT OPEN BEFORE [Date &amp; Time of the Bid Submission Deadline].”</b></p> <p>16.2. In addition to the identification required in <b>Sub-Clause 16.1</b>, the inner envelopes shall indicate the name and address of the Bidder to enable the Bid to be returned unopened in case it is declared late, under <b>ITB Clause 18</b>.</p> <p>16.3. If the outer envelope is not sealed and marked as above, the SBP BSC will assume no responsibility for the misplacement or premature opening of the Bid.</p>
<b>17. Deadline for Submission of Bids</b>	<p>17.1. Bids must be received (through an authorized representative or courier/postal service) by SBP BSC at the address specified in the <b>BDS</b>, no later than the bid submission deadline specified in the <b>BDS</b>. Bids submitted through telegraph, telex, fax or e-mail shall not be</p>

	<p>considered. Any bid received by SBP BSC after the deadline for submission prescribed in the Bid Data Sheet will be returned unopened to such Bidder.</p> <p>17.2. SBP BSC may extend the deadline for submission of bids by issuing an amendment under <b>ITB Clause 8</b>, in which case all rights and obligations of SBP BSC and the Bidders previously subject to the original deadline will then be subject to the new deadline.</p>
<b>18. Late Bids</b>	<p>18.1. Any Bid received (through an authorized representative or courier/postal service) by SBP BSC after the deadline prescribed in <b>ITB Clause 17</b> will be returned unopened to the Bidder.</p>
<b>19. Modification and Withdrawal of Bids</b>	<p>19.1. The Bidder may modify or withdraw its bid after the bid's submission, provided that written notice of the modification, including substitution or withdrawal of the bids, is received by the SBP BSC before the deadline prescribed for submission of bids under <b>ITB Clause 17</b>.</p> <p>19.2. No bid can be modified after the deadline for submission of bids.</p> <p>19.3. No bid can be withdrawn in the interval between the deadline for submission of bids and the expiry of the period of bid validity, specified by the Bidder on the Bid Form. Withdrawal of a bid during this interval will result in the Bidder's forfeiture of its bid security.</p>

<b>E. Bid Opening and Evaluation</b>	
<b>20. Bid Opening</b>	<p>20.1. The Bank will open all bids, including modifications, in public, in the presence of Bidder's representatives who choose to attend, at the time, on the date, and at the place specified in the <b>BDS</b>.</p> <p>20.2. For in person meeting, the Bidders' representatives shall sign an attendance sheet as proof of their participation.</p>
<b>21. The process to Be Confidential</b>	<p>21.1. The disclosure of information relating to the examination, clarification, evaluation, comparison of bids and recommendations for the award of a contract shall be subject to <b>Rule 41 of PPR-2004</b>.</p> <p>21.2. Information relating to evaluation of bids and recommendations concerning to award of the contract shall not be disclosed by SBP BSC to the Bidders or to any other person who is not officially concerned with the process, until the announcement of the result of evaluation.</p> <p>21.3. The Bidder shall not disclose or attempt to make public any information relating to the bidding documents, bidding process and award of the contract to any person or entity without SBP BSC's prior written consent.</p>



<b>E. Bid Opening and Evaluation</b>	
	<p>21.4. In case of any disclosure related to the bidding process and contractual obligations at any stage by any Bidder and/or service provider, SBP BSC may reject its bid and/or terminate the contract.</p> <p>21.5. Any effort by a Bidder to influence the Bank in its decisions on bid evaluation, bid comparison, or contract award may result in the rejection of the Bidder's bid.</p>
<b>22. Clarification of Bids</b>	22.1. During the bid evaluation, the Bank may, at its discretion, ask the Bidder for clarification of its bid. - v. **“obstructive practices”** which means harming or threatening to harm, directly or indirectly, persons to influence their participation in a procurement process, or affect the execution of a contract;”

However, such barring action shall be undertaken only after providing an adequate opportunity of being heard to the Bidder who is to be barred and blacklisted.

35.4. The receipt for any money paid by the Bidders will not be considered as an acknowledgment of payment to the Bidder unless such receipt is signed by a duly authorized officer of the SBP BSC and the Bidder shall be solely responsible for seeing that a proper receipt is provided.

35.5. **Under Rule 7 of PPR-2004**, Bidder undertakes to sign an Integrity pact in accordance with the prescribed format given in

Conversely, Bidders providing consulting services for the preparation or implementation of a project, and any of its affiliates shall be disqualified from subsequently providing goods or works or services other than consulting services resulting from or directly related to the firm's consulting services for such preparation or implementation.
- ii. A Bidder (including its Personnel) or any of its affiliates shall not be engaged for any assignment that, by its nature, may conflict with another assignment of the Bidder to be executed for the same or another client.
- iii. A Bidder (including its Personnel) that has a business or family relationship with a member of the SBP BSC's staff who is directly or indirectly involved in any part of
  - a) the preparation of the specifications of the goods,
  - b) the selection process for such assignment, or
  - c) Supervision of the Contract may not be awarded a contract unless the conflict stemming from this relationship has been resolved in a manner acceptable to the appropriate authority within the SBP BSC.

## 6. Quality Assurance & Compliance of Applicable Laws

## 7. Complaint/Dispute Resolution Mechanism

- 7.1. The service provider shall resolve the operational issues and complaints arising from the non-performance of its services or the performance of any of its services not executed as per the contract agreement.
- (a) The Service Provider shall nominate suitable official(s) to resolve the complaints and operational issues.
  - (b) In case of unsatisfactory services or absence of any resource due to leave or any other reason, the Bank's designated official will communicate/convey to the service provider or its designated official(s) for replacement/substitute services. The service provider shall provide the replacement/substitute to this effect within 24 hours.
  - (c) Due to any reason, if the service provider is unable to provide a replacement/substitute of services as mentioned in the sub-clause above within 24 hours, the Bank may deduct the charges per instance as mentioned in the Special Conditions of Contract (SCC) on account of non-compliance of the contract agreement.
  - (d) To ensure smooth execution of services, it is recommended that service provider maintain a pool of reserve resources, to be deployed in case of absence/leave of any resource.
  - (e) During contract execution, if any issue arises between the Client and the Service Provider due to any reason, including the deduction of charges on accounts of the quality assurance, provisioning of the backup services, substitutions/replacement of the services, performance and/or non-performance of the services or any other matter relating to the contractual obligations on the part of the Service Provider, the final decision regarding the resolution of the dispute shall be made as per provisions of the contract.
- 7.2. The Service Provider shall be independently responsible for ensuring the operability of the services provided at any service points, w.r.t training, for weapon handling, firing practice, firefighting, ethics and general public dealing as per the SOPs/policies of the Government.
- 7.3. All the security services, including the supervisory services provided by the service provider, shall complement the Bank's overall security plan as exercised by the Bank.

## 8. Payments

- 8.1. The payment shall be made against the actual utilization of services and on monthly-basis subject to the certification of satisfactory performance by the authorized representatives of the Client.

## Services to be Performed by Sub-Service Providers

- Sub-Contracting is **NOT** allowed.
