Invitation No. GSU (PROC)/ 32758 / CCTV / 2022-23 Date: 19 June 2023

- 1. This Invitation to Bids follows the Procurement Advertisement (PA) No. GSU (PROC)/32758/CCTV / 2022-23 for the procurement of "Supply, Installation, Testing and Commissioning of IP Based CCTV System at SBP Banking Services Corporation, Quetta".
- 2. The SBP Banking Services Corporation has reserved the funds for the procurement planned during the financial year 2022-23. It is intended that part of the proceeds of the fund will be used to cover eligible payment under the contract for the procurement.
- **3.** SBP Banking Services Corporation now invites sealed bids from eligible Suppliers to acquire CCTV System that meet the following eligibility criteria:
 - a. Bidder must be Original Equipment Manufacturer (OEM) or OEM's Authorized Agent of the offered CCTV Cameras in Pakistan;
 - b. Bidder must have experience of supplying/installing 50 CCTV Cameras in at least 03 (three) verifiable organizations during last 05 (five) years;
 - *c.* Bidder must have Annual Sales volume/Gross Turnover of at least Rs. 05 million in any of the last 03 (three) years;
 - *d.* Bidder should have at least three (03) certified technicians/resources to carry out the repair and maintenance of supplied equipment(s);
 - *e.* Bidder must be registered with Income and Sales Tax Department and must appear on Active Taxpayer List of FBR;
 - f. Bidder must not have been blacklisted or be in breach of performance with SBP or any Organization(s).
- **4.** The bidding shall be conducted in line with the Single Stage Two Envelope Procedure of the Public Procurement Rules 2004 and any Regulations, Regulatory Guides, Procurement Guidelines or Instructions issued by the Authority (from time to time) and is open to all potential bidders.
- 5. All bids must be accompanied by a Bid Security in an acceptable form amounting to PKR 17,000/-.
