- 1. This Invitation to Bids follows the Procurement Advertisement (PA) No. . GSD (PROC-III)/68220 / Exit & Entry Control / 2023-24 for the procurement of "Supply, Installation, Testing and Commissioning of Vehicle Entry/Exit Control System at SBP Banking Services Corporation".
- **2.** The SBP Banking Services Corporation has reserved the funds for the procurement planned during the financial year 2023-24. It is intended that part of the proceeds of the fund will be used to cover eligible payment under the contract for the procurement.
- **3.** SBP Banking Services Corporation now invites sealed bids from eligible Suppliers to acquire *Entry/Exit Control System* that meet the following eligibility criteria:
 - a. Bidder must be Original Equipment Manufacturer (OEM) or OEM's Authorized Agent of the offered System in Pakistan;
 - b. Bidder must have experience of supplying similar entry control equipment to at least 01 (one) verifiable organizations during last 05 (five) years;
 - c. Bidder must have Annual Sales volume/Gross Turnover of at least PKR. 20 (twenty) million in any of the last 03 (three) years;
 - d. Bidder must be registered with Income and Sales Tax Department and must appear on Active Taxpayer List of FBR;
 - e. Bidder must not have been blacklisted or be in breach of performance with SBP or any Organization(s).
- **4.** The Bidding shall be conducted in line with the Single Stage Two Envelope Procedure of the Public Procurement Rules 2004 (PPR-2004) and any Regulations, Regulatory Guides, Procurement Guidelines or Instructions issued by the Authority (from time to time) and is open to all potential bidders.
- 5. All technical bids must be accompanied by a Bid Security in an acceptable form amounting to PKR 150,000/-

- 7. The original bid along with one (01) copy, properly filled in, and enclosed in sealed envelope(s), must be delivered at the office of the undersigned on or before Monday, January 22, 2024 11:00 AM.
