1. This Invitation to Bids follows the Procurement Advertisement (PA) No. *GSU (2023-24) / 6805-24 / Fire Suppression / 2023-24* for the procurement of ***“Supply, Installation, Testing and Commissioning of Fire Suppression System at IT Server Room at SBP Banking Services Corporation Peshawar”***.
2. The SBP Banking Services Corporation has reserved the funds for the procurement planned during the financial year 2023-24. It is intended that part of the proceeds of the fund will be used to cover eligible payment under the contract for the procurement.
3. SBP Banking Services Corporation now invites sealed bids from eligible Suppliers to acquire *Fire suppression system* that meet the following eligibility criteria:
 - a. *Bidder must be Original Equipment Manufacturer (OEM) or OEM’s Authorized Agent of the offered Fire Suppression in Pakistan;*
 - b. *Bidder must have experience of supplying Fire suppression systems to at least 03 (three) verifiable organizations during last 03 (three) years;*
 - c. *Bidder must have Annual Sales volume/Gross Turnover of at least PKR. 05 (five) million in any of the last 03 (three) years;*
 - d. *Bidder must have verifiable presence in Peshawar/Islamabad/Rawalpindi;*
 - e. *Bidder must be registered with Income and Sales Tax Department and must appear on Active Taxpayer List of FBR;*
 - f. *Bidder must not have been blacklisted or be in breach of performance with SBP or any Organization(s).*
4. The Bidding shall be conducted in line with the Single Stage Two Envelope Procedure of the Public Procurement Rules 2004 (PPR-2004) and any Regulations, Regulatory Guides, Procurement Guidelines or Instructions issued by the Authority (from time to time) and is open to all potential bidders.
5. All technical bids must be accompanied by a Bid Security in an acceptable form amounting to **PKR 170,000/-**.
6. This Invitation to Bids / Bidding Documents is also available on the websites: <http://www.ppra.org.pk> and <http://www.sbp.org.pk>.
7. The original bid along with one (01) copy, properly filled in, and enclosed in sealed envelope(s), must be delivered at the office of the undersigned on or before **03:00 PM 5th March 2024**. The bids (technical part of the bids) will be opened same day at **03:30 PM** in public and in the presence of bidders’ representatives who choose to attend the opening at the **Meeting Room, SBP BSC Peshawar**.

Section II. Instructions to Bidders (ITBs)

<u>A. Introduction</u>	
1. Scope of Application	1.1 The Procuring Agency (PA), as indicated in the Bid Data Sheet (BDS) invites Bids for the equipment and related services as specified in the BDS and Section V - Technical Specifications & Schedule of Requirements. The successful Bidders will be expected to supply and install the equipment within the specified period and timeline(s) as stated in the BDS.
2. Sources of Funds	2.1 Source of funds is referred in Clause-2 of Invitation to Bids.
3. Eligible Bidders	<p>3.1 A Bidder may be natural person, company or firm or public or semi-public agency of Pakistan or of any foreign country, or any combination of them with a formal existing agreement (on Judicial Papers) in the form of a joint venture, consortium, or association. In the case of a joint venture, consortium, or association, all members shall be jointly and severally liable for the execution of the Contract in accordance with the terms and conditions of the Contract. The joint venture, consortium, or association shall nominate a Lead Member as nominated in the BDS, who shall have the authority to conduct all business for and on behalf of any and all the members of the joint venture, consortium, or association during the Bidding process, and in case of award of contract, during the execution of contract.</p> <p>3.2 The appointment of Lead Member in the joint venture, consortium, or association shall be confirmed by submission of a valid Power of Attorney to the Procuring Agency.</p> <p>3.3 Verifiable copy of the agreement that forms a joint venture, consortium or association shall be required to be submitted as part of the Bid.</p> <p>3.4 Any bid submitted by the joint venture, consortium or association shall indicate the part of proposed contract to be performed by each party and each party shall be evaluated (or post qualified if required) with respect to its contribution only, and the responsibilities of each party shall not be substantially altered without prior written approval of the Procuring Agency and in line with any instructions issued by the Authority.</p> <p>3.5 The invitation for Bids is open to all prospective supplier, manufacturers or authorized agents/dealers subject to any provisions of incorporation or licensing by the respective national incorporating agency or statutory body established for that particular trade or business.</p> <p>3.6 Foreign Bidders must be locally registered with the appropriate national incorporating body or the statutory body, before participating in the national/international competitive tendering</p>



with the exception of such procurements made by the foreign missions of Pakistan. For such purpose the bidder must have to initiate the registration process before the bid submission and the necessary evidence shall be submitted to the procuring agency along with their bid, however, the final award will be subject to the complete registration process.

3.7 A Bidder shall not have a conflict of interest. All Bidders found to have a conflict of interest shall be disqualified. A Bidders may be considered to have a conflict of interest with one or more parties in this Bidding process, if they:

- a. are associated or have been associated in the past, directly or indirectly with a firm or any of its affiliates which have been engaged by the Procuring Agency to provide consulting services for the preparation of the design, specifications and other documents to be used for the procurement of goods and related services to be procured under this Invitation for Bids.
- b. have controlling shareholders in common; or
- c. receive or have received any direct or indirect subsidy from any of them; or
- d. have the same legal representative for purposes of this Bid; or
- e. have a relationship with each other, directly or through common third parties, that puts them in a position to have access to information about or influence on the Bid of another Bidder, or influence the decisions of the Procuring Agency regarding this Bidding process; or
- f. Submit more than one Bid in this Bidding process.

3.8 A Bidder may be ineligible if –

- a. he is declared bankrupt or, in the case of company or firm, insolvent;
- b. payments in favor of the Bidder is suspended in accordance with the judgment of a court of law other than a judgment declaring bankruptcy and resulting (in accordance with the national laws) in the total or partial loss of the right to administer and dispose of its property;
- c. legal proceedings are instituted against such Bidder involving an order suspending payments and which may result, in accordance with the national laws, in a declaration of bankruptcy or in any other situation entailing the total or partial loss of the right to administer and dispose of the property;
- d. the Bidder is convicted, by a final judgment, of any offence involving professional conduct;
- e. the Bidder is blacklisted and hence debarred due to involvement in corrupt and fraudulent practices, or



	<p>performance failure or due to breach of bid securing declaration.</p> <p>f. The firm, supplier and contractor is blacklisted or debarred by a foreign country, international organization, or other foreign institutions for the period defined by them.</p> <p>3.9 Bidders shall provide to the Procuring Agency evidence of their eligibility, proof of compliance with the necessary legal requirements to carry out the contract effectively.</p> <p>3.10 Bidders shall provide such evidence of their continued eligibility to the satisfaction of the Procuring Agency, as the Procuring Agency shall reasonably request.</p> <p>3.11 Bidders shall submit proposals relating to the nature, conditions and modalities of sub-contracting wherever the sub-contracting of any elements of the contract amounting to the more than ten (10) percent of the Bid price is envisaged.</p>
4. Eligible Goods and Related Services	<p>4.1 All the goods and related services to be supplied under the contract shall have their origin in eligible source countries, and all expenditures made under the contract will be limited to such goods and services. For purpose of this Bid, ineligible countries are stated in the section-4 titled as “Eligible Countries”.</p> <p>4.2 For purposes of this Clause, “origin” means the place where the goods are mined, grown, cultivated, produced, manufactured, or processed, or through manufacture, procession, or assembly, another commercially recognized article results that differs substantially in its basic characteristics from its imported components or the place from where the related services are/to be supplied.</p> <p>4.3 The nationality of the supplier that supplies and install the goods shall not determine the origin of the goods.</p> <p>4.4 To establish the eligibility of the Goods and the related services, Bidders shall fill the country of origin declarations included in the Form of Bid.</p> <p>4.5 If so required in the BDS, the Bidder shall demonstrate that it has been duly authorized by the manufacturer of the goods to deliver in Pakistan (or in respective country in case of procurement by the Pakistani Missions abroad), the goods indicated in its Bid.</p>
5. One Bid per Bidder	<p>5.1 A bidder shall submit only one Bid, in the same bidding process, either individually as a Bidder or as a member in a joint venture or any similar arrangement.</p>



	<p>5.2 No bidder can be a sub-contractor while submitting a Bid individually or as a member of a joint venture in the same Bidding process.</p> <p>5.3 A person or a firm cannot be a sub-contractor with more than one bidder in the same bidding process.</p>
<p>6. Cost of Bidding</p>	<p>6.1 The Bidder shall bear all costs associated with the preparation and submission of its Bid, and the Procuring Agency shall in no case be responsible or liable for those costs, regardless of the conduct or outcome of the bidding process.</p>
<p><u>B. Bidding Documents</u></p>	
<p>7. Contents of Bidding Documents</p>	<p>7.1 The goods required, bidding procedures, and terms and conditions of the contract are prescribed in the Bidding Documents. In addition to the Invitation to Bids, the Bidding Documents which should be read in conjunction with any addenda issued in accordance with ITB 9.2 include:</p> <p style="padding-left: 40px;"> Section I -Invitation to Bids Section II Instructions to Bidders (ITBs) Section III Bid Data Sheet (BDS) Section IV Eligible Countries Section V Schedule of Requirements and Technical Specifications Section VI Standard Forms Section VII General Conditions of Contract (GCC) Section VIII Special Conditions of Contract (SCC) Section IX Contract Forms </p> <p>7.2 The number of copies to be completed and returned with the Bid is specified in the BDS.</p> <p>7.3 The Procuring Agency is not responsible for the completeness of the Bidding Documents and their addenda, if they were not obtained directly from the Procuring Agency or the signed pdf version from downloaded from the website of the Procuring Agency. However, Procuring Agency shall place both the pdf and same editable version to facilitate the bidder for filling the forms.</p> <p>7.4 The Bidder is expected to examine all instructions, forms, terms and specifications in the Bidding Documents. Failure to furnish all the information required in the Bidding Documents will be at the Bidder’s risk and may result in the rejection of his Bid.</p>
<p>8. Clarification of Bidding Documents</p>	<p>8.1 A prospective Bidder requiring any clarification of the Bidding Documents may notify the Procuring Agency in writing or in electronic form that provides record of the content of communication at the Procuring Agency's address indicated in the BDS.</p>



	<p>8.2 The Procuring Agency will within three (3) working days after receiving the request for clarification, respond in writing or in electronic form to any request for clarification provided that such request is received not later than three (03) days prior to the deadline for the submission of Bids as prescribed in ITB 23.1. However, this clause shall not apply in case of alternate methods of Procurement.</p> <p>8.3 Copies of the Procuring Agency's response will be forwarded to all identified Prospective Bidders through an identified source of communication, including a description of the inquiry, but without identifying its source.</p> <p>In case of downloading of the Bidding Documents from the website of PA, the response of all such queries will also be available on the same link available at the website.</p> <p>8.4 Should the Procuring Agency deem it necessary to amend the Bidding Documents as a result of a clarification, it shall do so following the procedure under ITB 9.</p> <p>8.5 If indicated in the BDS, the Bidder's designated representative is invited at the Bidder's cost to attend a pre-Bid meeting at the place, date and time mentioned in the BDS. During this pre-Bid meeting, prospective Bidders may request clarification of the schedule of requirement, the Evaluation Criteria or any other aspects of the Bidding Documents.</p> <p>8.6 Minutes of the pre-Bid meeting, if applicable, including the text of the questions asked by Bidders, including those during the meeting (without identifying the source) and the responses given, together with any responses prepared after the meeting will be transmitted promptly to all prospective Bidders who have obtained the Bidding Documents. Any modification to the Bidding Documents that may become necessary as a result of the pre-Bid meeting shall be made by the Procuring Agency exclusively through the use of an Addendum pursuant to ITB 9. Non-attendance at the pre-Bid meeting will not be a cause for disqualification of a Bidder.</p>
<p>9. Amendment of Bidding Documents</p>	<p>9.1 Before the deadline for submission of Bids, the Procuring Agency for any reason, whether at its own initiative or in response to a clarification requested by a prospective Bidder or pre-bid meeting may modify the Bidding Documents by issuing addenda.</p> <p>9.2 Any addendum issued including the notice of any extension of the deadline shall be part of the Bidding Documents pursuant to ITB 7.1 and shall be communicated in writing or in any identified electronic form that provide record of the content of communication to all the bidders who have obtained the Bidding Documents from the Procuring Agency. The Procuring Agency shall promptly publish the Addendum at the Procuring Agency's web page identified in the BDS:</p>



	<p>Provided that the bidder who had either already submitted their bid or handed over the bid to the courier prior to the issuance of any such addendum shall have the right to withdraw his already filed bid and submit the revised bid prior to the original or extended bid submission deadline.</p> <p>9.3 To give prospective Bidders reasonable time in which to take an addendum/corrigendum into account in preparing their Bids, the Procuring Agency may, at its discretion, extend the deadline for the submission of Bids: Provided that the Procuring Agency shall extend the deadline for submission of Bid, if such an addendum is issued within last three (03) days of the Bid submission deadline.</p>
<p><u>C. Preparation of Bids</u></p>	
<p>10. Language of Bid</p>	<p>10.1 The Bid prepared by the Bidder, as well as all correspondence and documents relating to the Bid exchanged by the Bidder and the Procuring Agency shall be written in the English language unless otherwise specified in the BDS. Supporting documents and printed literature furnished by the Bidder may be in another language provided they are accompanied by an accurate translation of the relevant pages in the English language unless specified in the BDS, in which case, for purposes of interpretation of the Bidder, the translation shall govern.</p>
<p>11. Documents and Sample(s) Constituting the Bid</p>	<p>11.1 The Bid prepared by the Bidder shall constitute the following components: -</p> <ul style="list-style-type: none"> a) Form of Bid and Bid Prices completed in accordance with ITB 14 and 15; b) Details of the Sample(s) where applicable and requested in the BDS. c) Documentary evidence established in accordance with ITB 13 that the Bidder is eligible and/or qualified for the subject bidding process; d) Documentary evidence established in accordance with ITB 13.3(a) that the Bidder has been authorized by the manufacturer to deliver the goods into Pakistan, where required and where the supplier is not the manufacturer of those goods; e) Documentary evidence established in accordance with ITB 12 that the goods and related services to be supplied by the Bidder are eligible goods and services, and conform to the Bidding Documents; f) Bid security or Bid Securing Declaration furnished in accordance with ITB 18; g) Duly Notarized Power of Attorney authorizing the signatory of the Bidder to submit the bid; and h) Any other document required in the BDS



	<p>11.2 Where a sample(s) is required by a procuring agency, the sample shall be:</p> <ul style="list-style-type: none"> (a) submitted as part of the bid, in the quantities, dimensions and other details requested in the BDS; (b) carriage paid; (c) received on, or before, the closing time and date for the submission of bids; and (d) evaluated to determine compliance with all characteristics listed in the BDS. <p>11.3 The Procuring Agency shall retain the sample(s) of the successful Bidder. A Procuring Agency shall reject the Bid if the sample(s)-</p> <ul style="list-style-type: none"> (a) do(es) not conform to all characteristics prescribed in the bidding documents; and (b) is / are not submitted within the specified time clearly mentioned in the Bid Data Sheet. <p>11.4 Where it is not possible to avoid using a propriety article as a sample, a Bidder shall make it clear that the propriety article is displayed only as an example of the type or quality of the goods being Bided for, and that competition shall not thereby be limited to the extent of that article only.</p> <p>11.5 Samples made up from materials supplied by a Procuring Agency shall not be returned to a Bidder nor shall a Procuring Agency be liable for the cost of making them.</p> <p>11.6 All samples produced from materials belonging to an unsuccessful Bidder shall be kept by the Procuring Agency till thirty (30) days from the date of award of contract or exhaust of all the grievance forums (including those pending at Authority's Level or in some Court of Law).</p>
<p>12. Documents Establishing Eligibility of the Goods and Related Services and Conformity to Bidding Documents</p>	<p>12.1 Pursuant to ITB 11, the Bidder shall furnish, as part of its Bid, all those documents establishing the eligibility in conformity to the terms and conditions specified in the Bidding Documents for all goods and related services which the Bidder proposes to deliver.</p> <p>12.2 The documentary evidence of the eligibility of all goods and related services shall consist of a statement in the Price Schedule of the country of origin of the goods and related services offered which shall be confirmed by a certificate of origin issued at the time of shipment.</p> <p>12.3 The documentary evidence of conformity of the goods and related services to the Bidding Documents may be in the form of literature, drawings, and data, and shall consist of:</p>



	<ul style="list-style-type: none"> a. a detailed description of the essential technical specifications and performance characteristics of the Goods; b. an item-by-item commentary on the Procuring Agency’s Technical Specifications demonstrating substantial responsiveness of the Goods and Services to those specifications, or a statement of deviations and exceptions to the provisions of the Technical Specifications; c. any other procurement specific documentation requirement as stated in the BDS. <p>12.4 The Bidder shall also furnish a list giving full particulars, including available sources and current prices of goods, spare parts, special tools, etc., necessary for the proper and continuing functioning of the Goods during the period specified in the BDS following commencement of the use of the goods by the Procuring Agency.</p> <p>12.5 For purposes of the commentary to be furnished pursuant to ITB 12.3(c) above, the Bidder shall note that standards for workmanship, material, and equipment, as well as references to brand names or catalogue numbers designated by the Procuring Agency in its Technical Specifications, are intended to be descriptive only and not restrictive. The Bidder may substitute alternative standards, brand names, and/or catalogue numbers in its Bid, provided that it demonstrates to the Procuring Agency’s satisfaction that the substitutions ensure substantial equivalence to those designated in the Technical Specifications.</p> <p>12.6 The required documents and other accompanying documents must be in English. In case any other language than English is used the pertinent translation into English shall be attached to the original version.</p>
<p>13. Documents Establishing the Eligibility and Qualification of the Bidder</p>	<p>13.1 Pursuant to ITB 11, the Bidder shall furnish, as part of its Bid, all those documents establishing the Bidder’s eligibility to participate in the bidding process and/or its qualification to perform the contract if its Bid is accepted.</p> <p>13.2 The documentary evidence of the Bidder’s eligibility to Bid shall establish to the satisfaction of the Procuring Agency that the Bidder, at the time of submission of its bid, is from an eligible country as defined in Section-4 titled as “Eligible Countries”.</p> <p>13.3 The documentary evidence of the Bidder’s qualifications to perform the contract if its Bid is accepted shall establish to the satisfaction of Procuring Agency that:</p> <ul style="list-style-type: none"> a) in the case of a Bidder offering deliver the goods under the contract which the Bidder did not manufacture or otherwise produce, the Bidder has been duly authorized by the Manufacturer or producer to deliver the goods in Pakistan;



	<p>b) The Bidder has the financial, technical, and supply/production capability necessary to perform the Contract, meets the qualification criteria specified in BDS.</p> <p>c) in the case of a Bidder not doing business within Pakistan, the Bidder is or will be (if awarded the contract) represented by an Agent in Pakistan equipped, and able to carry out the Supplier’s maintenance, repair, and spare parts-stocking obligations prescribed in the Conditions of Contract and/or Technical Specifications.</p> <p>d) That the Bidder meets the qualification criteria listed in the Bid Data Sheet.</p>
<p>14. Form of Bid</p>	<p>14.1 The Bidder shall fill the Form of Bid furnished in the Bidding Documents. The Bid Form must be completed without any alterations to its format and no substitute shall be accepted.</p>
<p>15. Bid Prices</p>	<p>15.1 The Bid Prices and discounts quoted by the Bidder in the Form of Bid and in the Price Schedules shall conform to the requirements specified below in ITB Clause 15 or exclusively mentioned hereafter in the bidding documents.</p> <p>15.2 All items in the Schedule of requirement must be listed and priced separately in the Price Schedule(s). If a Price Schedule shows items listed but not priced, their prices shall be construed to be included in the prices of other items.</p> <p>15.3 Items not listed in the Price Schedule shall be assumed not to be included in the Bid, and provided that the Bid is still substantially responsive in their absence or due to their nominal nature, the corresponding average price of the respective item(s) of the remaining substantially responsive bidder(s) shall be construed to be the price of those missing item(s):</p> <p>Provided that:</p> <ul style="list-style-type: none"> a) where there is only one (substantially) responsive bidder, or b) where there is provision for alternate proposals and the respective items are not listed in the other bids, <p>The procuring agency may fix the price of missing items in accordance with market survey, and the same shall be considered as final price.</p> <p>15.4 The Bid price to be quoted in the Form of Bid in accordance with ITB 15.1 shall be the total price of the Bid, excluding any discounts offered.</p> <p>15.5 The Bidder shall indicate on the appropriate Price Schedule, the unit prices (where applicable) and total Bid price of the goods it proposes to deliver under the contract.</p> <p>15.6 Prices indicated on the Price Schedule shall be entered separately in the following manner:</p>

- 26.1 The Procuring Agency will open all Bids, in public, in the presence of Bidders’ or their representatives who choose to attend, and other parties with a legitimate interest in the Bid proceedings at the place, on the date and at the time, specified in the BDS. The Bidders’ representatives present shall sign a register as proof of their attendance.
- 26.2 First, envelopes marked “WITHDRAWAL” shall be opened and read out and the envelope with the corresponding bid shall not be opened, but returned to the Bidder. No bid withdrawal shall be permitted unless the corresponding Withdrawal Notice contains a valid authorization to request the withdrawal and is read out at bid opening.
- 26.3 Second, outer envelopes marked “SUBSTITUTION” shall be opened. The inner envelopes containing the Substitution Bid shall be exchanged for the corresponding Original Bid being substituted, which is to be returned to the Bidder unopened. No envelope shall be substituted unless the corresponding Substitution Notice contains a valid authorization to request the substitution and is read out and recorded at bid opening.
- 26.4 Next, outer envelopes marked “MODIFICATION” shall be opened. No Technical Proposal and/or Financial Proposal shall be modified unless the corresponding Modification Notice contains a valid authorization to request the modification and is read out and recorded at the opening of the Bids. Any Modification shall be read out along with the Original Bid except in case of Single Stage Two Envelope Procedure where only the Technical Proposal, both Original as well as Modification, are to be opened, read out, and recorded at the opening. Financial Proposal, both Original and Modification, will remain unopened till the prescribed financial bid opening date.
- 26.5 Other envelopes holding the Bids shall be opened one at a time, in case of Single Stage One Envelope Procedure, the Bidders names, the Bid prices, the total amount of each Bid and of any alternative Bid (if alternatives have been requested or permitted), any discounts, the presence or absence of Bid Security, Bid Securing Declaration and such other details as the Procuring Agency may consider appropriate, will be announced by the Procurement Evaluation Committee.
- 26.6 In case of Single Stage Two Envelope Procedure, the Procuring Agency will open the Technical Proposals in public at the address, date and time specified in the **BDS** in the presence of Bidders` designated representatives who choose to attend and other parties with a legitimate interest in the Bid proceedings. The Financial Proposals will remain unopened and will be held in custody of the Procuring Agency until the specified time of their opening.



	<p>26.7 The envelopes holding the Technical Proposals shall be opened one at a time, and the following read out and recorded: (a) the name of the Bidder; (b) whether there is a modification or substitution; (c) the presence of a Bid Security, if required; and (d) Any other details as the Procuring Agency may consider appropriate.</p> <p>26.8 Bids not opened and not read out at the Bid opening shall not be considered further for evaluation, irrespective of the circumstances. 4.1 GENERAL:

This specification outlines the requirements for a "Total Flood" Clean Agent Fire Suppression System utilizing **FK-5-1-12** as the fire extinguishing agent and with a detection and control system. The work described in this specification includes all engineering, labor, materials, equipment and services necessary, and required, to complete and test the suppression and detection system.

4.2 REQUIREMENTS:

The Clean Agent Fire Suppression System installation shall be made in accordance with the drawings, specifications and applicable standards. Should a conflict occur between the drawings and specifications, the specifications shall prevail.



4.3 EXCLUSIONS:

The work listed below shall be provided by others, or under other sections of this specification:

- 230 VAC power supply to the system control panel.
- Interlock wiring and conduit for shutdown of HVAC, dampers and/or electric power supplies, relays or shunt trip breakers.
- Connection to local/remote fire alarm systems, listed central alarm station(s).

4.4 QUALITY ASSURANCE:**A) MANUFACTURER:**

- The manufacturer of the clean agent system hardware and detection components shall have a minimum of 10 years' experience in the design and manufacture of similar types of suppression systems and who refer to similar installations providing satisfactory service.
- The name of the manufacturer, part numbers and serial numbers shall appear on all major components.
- All devices, components and equipment shall be new, standard products of the manufacturer's latest design and suitable to perform the functions intended.
- All suppression devices and equipment shall be UL listed & FM approved.
- All detection devices shall be EN approved OR UL listed & FM approved.
- Locks for all cabinets shall be keyed alike.

B) INSTALLER:

- The installing contractor shall be trained by the supplier to design, install, test and maintain a clean agent system.
- The installing contractor shall be an experienced firm regularly engaged in the installation of automatic clean agent, or similar, fire suppression systems in strict accordance with all applicable standards.
- The installing contractor must have a minimum of two (2) years' experience in the design, installation and testing of clean agent, or similar, fire suppression systems. A list of systems of a similar nature and scope shall be provided on request.
- The installing contractor shall maintain, or have access to, a clean agent recharging station. The installing contractor shall provide proof of his ability to recharge the largest clean agent system within 24 hours after a discharge. Include the amount of bulk agent storage available.
- The installing contractor shall be an authorized stocking distributor of the clean agent system equipment so that immediate replacement parts are available from inventory.
- The installing contractor shall show proof of emergency service available on a twenty-four hour, seven-day-a-week basis.

C) SUBMITTALS:

The installing contractor shall submit the following design information and drawings for approval prior to starting work on this project:

- Field installation layout drawings having a scale of not less than 1/8" =1'-0" (1:100m) detailing the location of all agent storage tanks, pipe runs including pipe sizes and lengths, control panel(s), detectors, manual pull stations, abort stations, audible and visual alarms, etc.



- Auxiliary details and information such as maintenance panels, door holders, special sealing requirements and equipment shutdowns.
- Separate layouts, or drawings, shall be provided for each level, (i.e.; room, underfloor, and above ceiling) and for mechanical and electrical work.
- A separate layout or drawing, shall show isometric details of agent storage containers, mounting details and proposed pipe runs and sizes.
- Electrical layout drawings shall show the location of all devices and include point-to-point conduit runs and a description of the method(s) used for detector mounting.
- Provide an internal control panel wiring diagram which shall include power supply requirements and field wiring termination points.
- Complete hydraulic flow calculations, from UL & FM Approved Flow Calculation Program, shall be provided for all engineered Clean Agent systems. The individual sections of pipe to be used, as shown on the isometrics, must be identified and included in the calculation. Total agent discharge time must be shown and detailed by zone.
- Provide calculations for the battery stand-by power supply taking into consideration the power requirements of all alarms, initiating devices and auxiliary components under full load conditions.
- A complete sequence of operation shall be submitted detailing all alarm devices, shutdown functions, remote signaling, damper operation, time delay and agent discharge for each zone or system.
- Submit drawings, calculations and system component data sheets for approval to the local Fire Prevention Agency, owners Insurance Underwriter, and all other Authorities Having Jurisdiction before starting installation. Submit approved plans to the Architect/Engineer for record.

4.5 SYSTEM DESCRIPTION AND OPERATION:

- The system shall be a Clean Agent Fire Suppression System utilizing FK-5-1-12 as the fire extinguishing agent supplied.

The Clean Agent Fire Suppression System shall provide a minimum design concentration of 4.7 %, by volume for **FK-5-1-12** in all areas and/or protected spaces (CLASS A, C Fires), at the minimum anticipated temperature within the protected area. As Per NFPA 2001, the system design shall not exceed a maximum exposure limit concentration level of 6%, by volume, unless provisions for room evacuation, before agent release, are provided. FK-5-1-12 gas systems designed to concentrations below 6 percent (corresponding to an oxygen concentration of 16 percent, sea level equivalent of oxygen) shall be permitted where means are provided to limit exposure to no longer than 1 minutes. All personnel should be able to leave the protected space prior to the discharge or at least within 1 minutes of the commencement of discharge.
- The system shall be complete in all ways. It shall include all mechanical and electrical installation, all detection and control equipment, agent storage containers, suppression agent, system actuation equipment, discharge nozzles, pipe and fittings, manual release and abort stations, audible and visual alarm devices, auxiliary devices and controls, shutdowns, alarm interface, caution/ advisory signs, functional checkout and testing, training and all other operations necessary for a functional U.L. Listed and F.M. Approved Clean Agent Fire Suppression System.



- Provide two (2) inspections during the first year of service. Inspections shall be made at 6-month intervals commencing when the system is first placed into normal service.
- The general contractor shall be responsible for sealing and securing the protected spaces against agent loss and/or leakage during the 10 minute "hold" period.
- The system(s) shall be actuated by a combination of Photo smoke and/or multi-detectors installed in accordance with the guidelines stated in NFPA 72.
- Detectors shall be wired in Sequential Detection method of operation, standard Cross-Zoned detection, or single detector release. No other detection / wiring arrangements will be acceptable.
- Automatic operation of each protected area shall be as follows:

Each system shall have its own supply of clean agent.

- The system design can be modular, central storage, or a combination of both design criteria utilizing a fast-acting piston valve. The valve shall contain a scored, non-fragmenting, piston to provide immediate total discharge of the suppression agent.
- Systems shall be designed in accordance with the manufacturer's guidelines.
- Each supply shall be located within the hazard area, or as near as possible, to reduce the amount of pipe and fittings required to install the system as specified in plot plan.
- The clean agent shall be stored in Agent Storage Containers. Containers shall be super-pressurized, with dry Nitrogen, to an operating pressure of 362 psi @ 70° F (25 bar @ 21° C). Containers shall be of high-strength alloy steel construction and conform to NFPA 2001.
- Containers shall be actuated by the following methods:
 - a) Single container applications (Electric) – By a Solenoid Valve Operator wired through a Solenoid Releasing Module This method allows mechanical release.
 - b) Multiple container applications (Electric / Pneumatic) – The 1st container is operated by a Solenoid Valve Operator wired through a Solenoid Releasing Module.
- Each container shall have a pressure gauge and low-pressure switch to provide visual and electrical supervision of the container pressure. The low-pressure switch shall be wired to the control panel to provide an audible and visual "Trouble" alarm in the event the container pressure drops below 288 psi (19 bar). The pressure gauge shall be color coded to provide an easy, visual indication of container pressure.
- Each container shall have a pressure relief provision that automatically operates when the internal temperature exceed 150° F (66° C).
- Engineered discharge nozzles shall be provided, within the manufacturer's guidelines, to distribute the suppression agent throughout the protected spaces. The nozzles shall be designed as per hydraulic calculations to provide proper agent quantity and distribution.
 - a) Nozzles shall be available in NPT sizes ¼" – 2.0" (8mm- 50mm). Each size shall be available in 360° distribution patterns.
- Distribution piping, and fittings, shall be installed in accordance with the manufacturer's requirements, NFPA 2001, ASTM 53 and seamless Sch 40 approved piping standards and guidelines. All distribution piping shall be installed by qualified individuals using good, accepted practices and quality procedures. All piping shall be adequately supported and anchored at all directional changes and nozzle locations.
 - b) All piping shall be reamed, blown clear and swabbed with suitable solvents to remove burrs, mill varnish and cutting oils before assembly.
 - c) All pipe threads shall be sealed with sealant tape with sealant solution applied to the male thread ONLY.



- d) All MS pipe pipes shall be painted with RAL 3000 RED color with 1 coat of primer & 2 coats of enamel.

4.7 ELECTRICAL REQUIREMENTS

4.7.1 CONTROL PANEL:

- The Control Panel and its components shall be LPCB & EN OR UL listed & FM approved for suppression releasing service.
- The Control Panel shall be tested with the Clean Agent Gas cylinders and system manufacturer approved for use with the cylinders. This is to ensure the reliability that all cylinders will be discharged upon activation. This is critical to the extinguishment of fire.
- The Control Panel shall perform all functions necessary to operate the system detection, actuation and auxiliary functions, as outlined.
- The Control Panel shall be capable of providing 18AH battery standby power supplies.
- The Control Panel shall be conventional microprocessor-based with hardware and software programming designed to support cross-zoned, sequential, Single Detector Release and Manual Release detection/actuation methods.
- The Control panel shall provide 100% supervision of initiating circuits to ensure the end points are constantly monitored for operating condition.
- The Control Panel shall provide the following minimum electrical requirements:
 - Status LEDs / display for troubleshooting:
 - a. AC normal
 - b. alarm
 - c. pre-discharge
 - d. release
 - e. supervisory
 - f. trouble
 - g. panel silenced
 - h. abort
 - i. release disabled / isolate
 - j. ground fault
 - Resettable and continuous auxiliary output power.
 - Transistor protection to prevent noise spikes and microprocessor failure from inadvertently activating release outputs.
 - A dedicated Disarm switch for release outputs.
 - Dedicated alarm and trouble contacts programmable for alarm, trouble, pre-discharge, discharge, abort, supervisory, depending on panel configuration.
 - 240 VAC input power source.
 - Exhaust fan cutoff relays.
 - There shall be provision of 24 VDC Nickel-Cadmium or Seal Lead Acid standby batteries of the maintenance free type, in case of main power supply failure. The batteries will automatically and instantaneously be switched into use as soon as the main supply fails. Such a failure shall be indicated both visually and



audibly at the panel. The batteries shall be trickle-charged during normal operating conditions.

- The Control Panel shall be equipped with a manually-operated discharge disable function to provide a safeguard against actual activation of the clean agent during system servicing and testing.
- In areas where the Control Panel is exposed to weather, the panel shall be shielded with a weather-proof casing.

4.7.2 AUTOMATIC DETECTORS

SMOKE DETECTORS

The system shall be furnished and installed with high performance photoelectric – HPO smoke detectors rightly applied for suppression systems. The detector head and twist-lock base shall be UL listed & FM approved OR EN & LPCB approved compatible with the Control Panel. The smoke detector shall have a status LED for visual indication of Fire. The detector may be reset using the Control Panel reset switch.

DETECTOR BASES

The detector bases shall be selected according to their operational characteristics and size of base.

4.7.3 MANUAL RELEASE (Electric):

The electric manual release switch shall be a dual action device which provides a means of manually discharging the Clean Agent Fire Suppression System when used in conjunction with Control System.

- The Manual Release switch shall be a Manual Pull station.
- The Manual Release switch or Manual Pull station shall be a dual action device requiring two distinct operations to initiate a system actuation.
- Manual actuation shall bypass the time delay, shall cause the system to discharge and shall cause all release and shutdown devices to operate in the same manner as if the system had operated automatically.
- Manual Release shall carry a glass protection.
- A Manual Release or Manual Pull switch shall be located at each exit from the protected hazard and shall have an advisory sign, provided at each location.

4.7.4 MANUAL RELEASE (Mechanical):

Mechanical Manual Release shall be made available in the event all battery back-up and commercial power is lost. The Solenoid Valve Operator is equipped with a manual strike button for mechanical manual release for actuation methods. Consideration should be given for convenience of operation and egress from the hazard area(s).

4.7.5 ABORT STATION:

The optional Abort Station shall be the "Dead Man" type and shall be located next to each manual switch. "Locking" or "Keyed" abort stations shall not be permitted. The



Abort Station shall be supervised and shall indicate a trouble condition at the Control Panel, if depressed, and no alarm condition exists. The Abort Station shall be located adjacent to each manual station.

4.7.6 AUDIBLE and VISUAL ALARMS:

Alarm audible and visual signal devices shall operate from the Control Panel. A Strobe device shall be placed outside, and above, each exit door from the protected space. Provide an advisory sign at each light location.

4.7.7 CAUTION and ADVISORY SIGNS:

Provide signs, as required, to comply with NFPA 2001 and the recommendations of the equipment supplier:

- Entrance sign: One (1) required at each entrance into a protected space.
- Manual Discharge sign: One (1) required at each manual discharge station.
- Flashing Light sign: One (1) required at each flashing light over each exit from a protected space.
- Hazard Area marking labels on wooden cabinets for each hazard area

4.7.8 SYSTEM and CONTROL WIRING:

- All system wiring shall be furnished and installed by the contractor.
- All wiring shall be installed in electrical metallic tubing (EMT) Powder coated and must be installed and kept separate from all other building wiring.
- All system components shall be securely supported independent of the wiring. Runs of conduit and wiring shall be straight, neatly arranged, properly supported, installed parallel and perpendicular to walls and partitions.
- The sizes of the conductors shall be those specified by the manufacturer. Color coded Fire rated wire shall be used. All wires shall be tagged at all junction points and shall be free from shorts, earth connections (unless so noted on the system drawings), and crosses between conductors. Final terminations between the control panel and the system field wiring shall be made under the direct supervision of a factory trained representative.
- All wiring shall be installed by qualified individuals, in a neat and workmanlike manner, to conform to the National Electrical Code, except as otherwise permitted for limited energy circuits, as described in NFPA 72. Wiring installation shall meet all local, state, province and/or country codes.
- The complete system electrical installation, and all auxiliary components, shall be connected to earth ground in accordance with the National Electrical Code.

4.8 SYSTEM INSPECTION AND CHECKOUT:

After the system installation has been completed, the entire system shall be checked out, inspected and functionally tested by qualified, trained personnel, in accordance with the manufacturer's recommended procedures and NFPA standards.



- All containers and distribution piping shall be checked for proper mounting and installation.
- All electrical wiring shall be tested for proper connection, continuity and resistance to earth.
- The complete system shall be functionally tested, in the presence of the owner or his representative, and all functions, including system and equipment interlocks, must be operational at least five (5) days prior to the final acceptance tests.
 - a) Each detector shall be tested in accordance with the manufacturers recommended procedures, and test values recorded.
 - b) All system and equipment interlocks, such as door release devices, audible and visual devices, equipment shutdowns, local and remote alarms, etc. shall function as required and designed.
 - c) Each control panel circuit shall be tested for trouble by inducing a trouble condition into the system. shall be tested for trouble by inducing a trouble condition into the system.

4.9 TRAINING REQUIREMENTS:

Prior to final acceptance, the installing contractor shall provide operational training to each shift of the owners' personnel. Each training session shall include system Control Panel operation, manual and (optional) abort functions, trouble procedures, supervisory procedures, auxiliary functions and emergency procedures.

4.10 OPERATION and MAINTENANCE:

Prior to final acceptance, the installing contractor shall provide complete operation and maintenance instruction manuals, four (4) copies for each system, to the owner. All aspects of system operation and maintenance shall be detailed, including piping isometrics, wiring diagrams of all circuits, a written description of the system design, sequence of operation and drawing(s) illustrating control logic and equipment used in the system. Checklists and procedures for emergency situations, troubleshooting techniques, maintenance operations and procedures shall be included in the manual.

4.11 ACCEPTANCE TESTS:

- At the time "As-Built" drawings and maintenance/operations manuals are submitted, the installing contractor shall submit a "Test Plan" describing procedures to be used to test the control system(s). The Test Plan shall include a step-by-step description of all tests to be performed and shall indicate the type and location of test apparatus to be employed. The tests shall demonstrate that the operational and installation requirements of this specification have been met. All tests shall be conducted in the presence of the owner and shall not be conducted until the Test Plan has been approved.
- The tests shall demonstrate that the entire control system functions as designed and intended. All circuits shall be tested: automatic actuation, solenoid and manual actuation, HVAC and power shutdowns, audible and visual alarm devices and manual override of abort functions. Supervision of all panel circuits, including AC power and battery power supplies, shall be tested and qualified.



- A room pressurization test shall be conducted, in each protected space, to determine the presence of openings, which would affect the agent system concentration levels. The test(s) shall be conducted using the Door Fan system with integrated computer program (with valid Calibration certificate). All testing shall be in accordance with NFPA 2001, current edition.
- If room pressurization testing indicates that openings exist which would result in leakage and/or loss of the extinguishing agent, the installing contractor shall be responsible for coordinating the proper sealing of the protected space(s) by the general contractor or his sub-contractor or agent. The general contractor shall be responsible for adequately sealing all protected space(s) against agent loss or leakage. The installing contractor shall inspect all work to ascertain that the protected space(s) have been adequately and properly sealed.
- If the first room pressurization test is not successful, in accordance with these specifications, the installing contractor shall direct the general contractor to determine, and correct, the cause of the test failure. The installing contractor shall conduct additional room pressurization tests, at no additional cost to the owner, until a successful test is obtained. Copies of successful test results shall be submitted to the owner for record.
- Upon acceptance by the owner, the completed system(s) shall be placed into service.
- Before putting equipment into permanent operation, the pipes must be pressure tested under the test pressure of 45 PSI. Pressure test is made on distribution piping, manifolds and pressure hoses from the pilot line. The pressure test must not be performed on electric actuator and container valves. Test pressure shall not fall by more than 20% during the time 10 min.

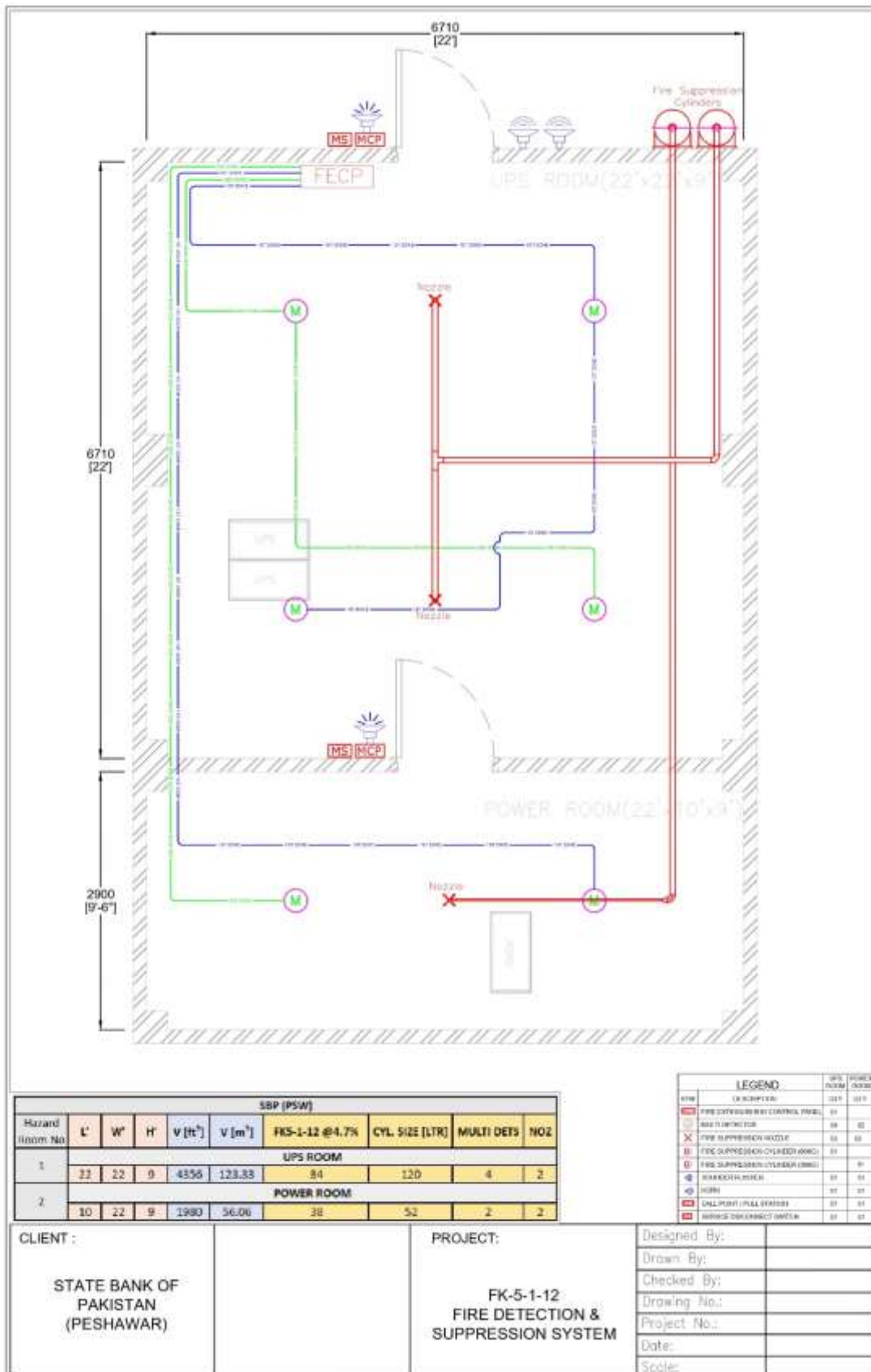
4.12 SYSTEM INSPECTIONS:

- The installing contractor shall provide two (2) inspections of each system, installed under this contract, during the one-year warranty period. The first inspection shall be at the six-month interval, and the second inspection at the 12-month interval, after system acceptance. Inspections shall be conducted in accordance with the manufacturer's guidelines, and the recommendations of NFPA 2001.
- Documents certifying satisfactory system(s) operation shall be submitted to the owner upon completion of each inspection.

4.13 WARRANTY:

All system components furnished, and installed under this contract, shall be guaranteed against defects in design, materials and workmanship for the full warranty period which is standard with the manufacturer, but in no case less than one (1) year from the date of system acceptance.
