- 1. This Invitation to Bids follows the Procurement Advertisement (PA) No. *NIBAF (PROC-IT)/244/ACS / 2023-24* for the procurement of *Supply, Installation, Testing and Commissioning of Wireless Audio Conference System*.
- 2. NIBAF has reserved the funds for the procurement planned during the financial year 2023-24. It is intended that part of the proceeds of the fund will be used to cover eligible payment under the contract for the procurement.
- **3.** NIBAF now invites sealed bids from eligible Suppliers to acquire Wireless Audio Conference System that meet the following eligibility criteria:
 - a. Bidder must be Original Equipment Manufacturer (OEM) or OEM's Authorized Agent of the offered Wireless Audio Conference System in Pakistan for each core item i.e. (Audio Conference System, PTZ Camera & Camera Controller);
 - b. Bidder must have experience of supplying/installing audio conference systems in at least five (5) verifiable organizations during last five (5) years, at least two (2) installations of Wireless Audio Conference System each having two (2) numbers of PTZ conference cameras integrated with system;
 - c. Bidder must be registered in Pakistan for at least ten (10) years;
 - *d.* Bidder must have Annual Sales Volume/Gross Turnover of at least Rs.50 million in any of the last three (3) years;
 - e. Bidder must be registered with Income and Sales Tax Department and must appear on Active Taxpayer List of FBR;
 - *f.* Bidder must not have been blacklisted or be in breach of performance with NIBAF or any Organization(s);
- 4. The bidding shall be conducted in line with the Rule 36 (b) Single Stage Two Envelope Procedure of the Public Procurement Rules 2004 and any Regulations, Regulatory Guides, Procurement Guidelines or Instructions issued by the Authority (from time to time) and is open to all potential bidders.
- 5. All bids must be accompanied by a Bid Security in an acceptable form amounting to PKR 80,000/-.

	Scope of Application	1.1	The Procuring Agency (PA), as indicated in the Bid Data Sheet (BDS) invites Bids for the equipment and related services as specified in the BDS and Section V - Technical Specifications & Schedule of Requirements. The successful Bidders will be expected to supply and install the equipment within the specified period and timeline(s) as stated in the BDS.		
2.		2.1	Source of funds is referred in Clause-2 of Invitation to Bids.		
3.	Eligible Bidders	3.1	A Bidder may be natural person, company or firm or public or semi-public agency of Pakistan or of any foreign country, or any combination of them with a formal existing agreement (on Judicial Papers) in the form of a joint venture, consortium, or association. In the case of a joint venture, consortium, or association, all members shall be jointly and severally liable for the execution of the Contract in accordance with the terms and conditions of the Contract. The joint venture, consortium, or association shall nominate a Lead Member as nominated in the BDS, who shall have the authority to conduct all business for and on behalf of any and all the members of the joint venture, consortium, or association during the Bidding process, and in case of award of contract, during the execution of contract.		
		3.2	The appointment of Lead Member in the joint venture, consortium, or association shall be confirmed by submission of a valid Power of Attorney to the Procuring Agency.		
		3.3	Verifiable copy of the agreement that forms a joint venture, consortium or association shall be required to be submitted as part of the Bid.

Eligible Bidders	3.6 Foreign Bidders must be locally registered with the appropriate national incorporating body or the statutory body, before participating in the national/international competitive tendering with the exception of such procurements made by the foreign missions of Pakistan. For such purpose the bidder must have to initiate the registration process before the bid submission and the necessary evidence shall be submitted to the procuring agency along with their bid, however, the final award will be subject to the complete registration process.
	3.7 A Bidder shall not have a conflict of interest. All Bidders found to have a conflict of interest shall be disqualified. A Bidders may be considered to have a conflict of interest with one or more parties in this Bidding process, if they:
	 a. are associated or have been associated in the past, directly or indirectly with a firm or any of its affiliates which have been engaged by the Procuring Agency to provide consulting services for the preparation of the design, specifications and other documents to be used for the procurement of goods and related services to be procured under this Invitation for Bids. b. have controlling shareholders in common; or c. receive or have received any direct or indirect subsidy from any of them; or d. have the same legal representative for purposes of this Bid; or e. have a relationship with each other, directly or through common third parties, that puts them in a position to have access to information about or influence on the Bid of another Bidder, or influence the decisions of the Procuring Agency regarding this Bidding process; or f. Submit more than one Bid in this Bidding process.
	 3.8 A Bidder may be ineligible if – a. he is declared bankrupt or, in the case of company or firm, insolvent; b. payments in favor of the Bidder is suspended in accordance with the judgment of a court of law other than a judgment declaring bankruptcy and resulting (in accordance with the national laws) in the total or partial loss of the right to administer and dispose of its property; c. legal proceedings are instituted against such Bidder involving an order suspending payments and which may result, in accordance with the national laws, in a declaration of bankruptcy or in any other situation entailing the total or partial loss of the right to administer and dispose of the property;
