### Cash Management - Monthly Stock Position

Dear Sir / Madam,

Please refer to SBP Accounts Department's (presently Finance Department) Circular No.01 dated 15<sup>th</sup> March, 2004 whereby all commercial banks' branches are maintaining denomination-wise statement of their respective cash balances. SBP now intends to collect the requisite information on a consolidated basis, which will enable us to identify trends of denomination-wise currency in circulation held by commercial banks separately between new and old denominations. This will further strengthen our cash management system, maintenance of inventory/stock practices, and demonetization process being followed for old design banknotes.

The denomination-wise data of cash balances will be submitted via SBP's automated system (data warehouse application/portal) as per enclosed template on monthly basis starting from February, 2012. The statement of  $29^{th}$  February, 2012 should be submitted by  $5^{th}$  March, 2012. Thereafter the monthly statement should be submitted by the  $5^{th}$  day of each month.

Training of banks' staff to input data via the automated system (data warehouse application/portal) will be conducted by the Statistics & Data Warehouse Department on  $23^{rd}$  and  $24^{th}$  January in the Computer Lab of LRC, SBP (as per attached schedule). You are advised to nominate two officials to be trained in the said system latest by  $19^{th}$  January, 2012.
