Main Job Responsibilities:

- Attend to the patients and prescribe medicine/investigation as deemed necessary.
- Give technical in order for bills of hospitals OPD/IPD, review hospital bills/individual claims, and ensure that treatment is covered under relevant Bank Rules.
- Visit assigned hospital(s), to ensure that cost effective and quality medical care is provided to eligible stakeholders admitted in the hospital upon the recommendation of physician/specialist.
- Ensures the compliance of relevant policies, SOPs and financial controls.
- Conduct clinical examinations of new recruits and serving employees for fitness test.
- Perform any other work which may be assigned by the CMO.
- Ensure compliance of policies and SOPs and safe keeping of record.

Eligibility Requirements:

- The candidate must be a Pakistani/AJK national having MBBS from a recognized and well reputed institution.
- Minimum 02 years' post-qualification experience as medical practitioner at a large hospital/corporate sector including one year house job comprising six months in medicine or allied subjects and six months in surgery as on the last date of submission of application.
- Maximum 35 years as on the last date of submission of application.

Selection Procedure:

- The candidates will be shortlisted on the basis of eligibility criteria and quality/relevance of professional experience. The shortlisted candidates shall be required to appear for written test/ interview before the Selection Board. Selected candidates will undergo medical examination by Bank's Medical Officer and those who are found medically fit shall be offered appointment in order of merit.

Compensation:

- Selected candidates will be offered market-based competitive compensation as admissible under the Bank's rules, which commensurate with qualification and experience of the candidate.

Terms of Employment:

- This is a contractual position, initially offered for a period of two (02) years. The contract may be renewed based on satisfactory performance and organizational requirements.
