Main Job Responsibilities:

- Provide comprehensive physiotherapy treatment and rehabilitation services to employees and their eligible dependents.
- Assess patient conditions, diagnose musculoskeletal / neurological / sports-related issues, and design individualized treatment plans.
- Conduct therapeutic exercises, manual therapy, electrotherapy, and use of physiotherapy modalities as needed.
- Guide patients on ergonomics, posture correction, and preventive physiotherapy for workplace-related conditions.
- Maintain accurate clinical records, document progress, and prepare periodic reports.
- Ensure proper maintenance and safe use of physiotherapy equipment in the BMC.
- Conduct awareness and training sessions for employees on injury prevention, fitness, and physical well-being.
- Work in close coordination with in-house doctors and medical staff for holistic patient care.

Eligibility Requirements:

- The candidate must be a Pakistani/AJK national having Doctor of Physical Therapy (DPT) degree from a recognized and well reputed institution. Preference will be given to candidates with MS/MPhil in Physiotherapy (Orthopedic, Neurological, or Sports specialization).
- Valid registration with Allied Health Professionals Council of Pakistan is mandatory.
- Minimum 5 years of post-qualification experience in physiotherapy at a reputed hospital/clinic/institution. Hands-on experience in musculoskeletal, neurological, sports injuries, and occupational physiotherapy preferred.
- Maximum 35 years as on the last date of submission of application (relaxable in case of higher qualification/experience).

Selection Procedure:

- The candidates will be shortlisted on the basis of eligibility criteria and quality/relevance of professional experience. The shortlisted candidates shall be required to appear for written test/ interview before the Selection Board. Selected candidates will undergo medical examination by Bank's Medical Officer and those who are found medically fit shall be offered appointment in order of merit.

Compensation:

- Selected candidates will be offered market-based competitive compensation as admissible under the Bank's rules, which commensurate with qualification and experience of the candidate.

Terms of Employment:

- This is a contractual position, initially offered for a period of two (02) years. The contract may be renewed based on satisfactory performance and organizational requirements.
