ORDER

### Islamabad, the 4th August, 2006

S. R. O. 803 (I)/2006.— In pursuance of entry 7 of item 29A of Schedule II to the Rules of the Business, 1973, in order to encourage research and development in the value added textile sectors and to allow and regulate research and development support in the home textiles, dyed and printed cloth manufacturing-*cum*-exporting units, the Federal Government is pleased to make the following order, namely:

1. Short title and commencement.---

- (1) This Order may be called the Research and Development Support Order, 2006.
- (2) It shall come into force at once and shall be deemed to have taken effect on the 1st July, 2006.

2. **Procedure and conditions.**— (1) The research and development support shall be provided to the home textiles, dyed and printed fabrics manufacturingcum-exporting units under Chapters 52, 55, 63 and 94 of the Pakistan Customs Tariff at the specified rate of FOB value of export as below:

(a)	Dye	ed and Printed Fabrics	=3%
	(under Chapters 52 and 55).		
(b)	Home Textiles (under Chapters 63 and 94).		
	(i)	White	= 3%
	(ii)	Dyed/Printed	= 5%

Note: All kinds of towels (unstitched) are not allowed

#### Explanation:-

List of value added textiles products (Fabrics, bedlinen, made ups and towels along with Chapters and H.S. code Nos. is at Annexure-III).

- (2) The research and development support shall be available only to manufacturing-cum-exporting units with inhouse dying and printing facility.
- (3) The research and development support shall be available for export to the following countries and regions:

USA, EU, CANADA, AUSTRALIA, JAPAN, NEWZEALAND, SWITZERLAND, MALAYSIA, INDONESIA, PEOPLE'S REPUBLIC OF CHINA, SOUTH AMERICA, MEXICO, SOUTH AFRICA, CIS COUNTRIES (RUSSIAN FEDERATION, UZBEKISTAN, TURKMENISTAN, KYRGHISTAN, KAZAKHISTAN, TAJIKISTAN, AZERBAIJAN, UKRAINE, BELARUS, GEORGIA, ARMENIA and MOLDAVIA).

- (4) The unit availing the facility shall be a member of any one of the following associations registered with the Director Trade Organizations, Ministry of Commerce, namely:
  - (a) All Pakistan Bedsheets & Upholstery Manufacturers Association (APBUMA);
  - (b) All Pakistan Textile Mills Association (APTMA);
  - (c) Pakistan Bed Wear Exporters Association (PBEA);
  - (d) Pakistan Textile Exporters Association (PTEA); and
  - (e) Towel Manufacturers Association (TMA).

- (5) The unit shall spend the amount received as research and development support from the Federal Government on the following activities, namely:
  - (a) Product development;
  - (b) Skill development and Training;
  - (c) Up gradation of information Technology;
  - (d) Professional Consultancy;
  - (e) Market research;
  - (f) Technical up gradation of production lines;
  - (g) Environment improvement;
  - (h) Resource conservation ;
  - (i) Production efficiencies; and
  - (j). Participation in Exhibitions.
- (6) The expenditure on the activities referred to in sub-paragraph (5) shall be reflected in the annual accounts and balance sheets of the exporting unit.
- (7) The unit shall lodge its claims for research and development support payment with field offices of SBP-Banking Services Corporation through his Authorized Dealer(s) in the form as set out in Annexure-1 to this Order duly supported by the documents as mentioned therein within thirty days of the date of realization of export proceeds.
- (8) Certification for research and development carried out by the unit shall be issued by any one of the Associations specified in subparagraph (4) of which the unit is a member, in the form as set out in Appendix-III to this Order. Before verifying the claims, the relevant Association shall carry out due diligence to ensure that the claim of the unit is based on facts.
- (9) Before submitting the claims, the authorized dealers shall scrutinize the applications carefully and submit the same duly certified by them as an undertaking in the form as set out in Annexure-II to this Order, to the field offices of the SBP-Banking Services Corporation. Such applications shall be received by the said field offices up to 11.00 A.M. on all working days.
- (10) The admissible research and development support payment as approved by the field office of the SBP-Banking Services Corporation shall be made by crediting the account of the concerned authorized dealer, who shall pay the amount to the unit within twenty-four hours of receipt of credit in their account.

- (11) In order to avoid delay or rejection of the research and development support claim, the authorized dealers at the time of certification of the E-Form, shall see that the description of the commodity is properly given in the E-Form and the invoices, are in accordance with the nomenclature given in Chapters 52, 55, 63 and 94 of the Pakistan Customs Tariff.
- (12) Authorized dealers, while forwarding applications for payment of research and development support shall invariably and prominently rubber stamp at the top of the triplicate copy of the relevant E-Form with the following narration namely:—

"Applications for Research and Development Support of Rs. Submitted to field office, SBP-Banking Services Corporation vide Forwarding Schedule No. Dated \_\_\_\_\_\_at Serial No. \_\_\_\_\_\_".

(13) The unit shall rubber stamp at the top of the copy of the Goods Declaration Form (containing examiner's report and MR date) prescribed under the Customs Act, 1969 (IV of 1969), the following narration, namely:---

> "Research and development support as notified shall be claimed for this consignment."

- (14 In case the unit's consignment includes items other than those falling under Chapters 52, 55, 63 and 94 of the Pakistan Customs Tariff a separate E-Form and shipping bill will be made for such items and commodities.
- (15) Applications containing discrepancies shall be returned to the Authorized Dealers within two working days between 2.30 P.M. and 3.30 P.M. for resubmission duly rectified within the period as indicated in sub-paragraph (6): While re-submitting the applications, authorized dealers shall quote the reference of the "forwarding schedule" under which the application was originally submitted.
- (16) No remittance on account of foreign importer's subsequent claims for refund of money on account of quality or short quantity etc., shall be allowed, unless proportional amount of Research and Development Support is refunded.
- (17) In case of exports against advance payments, claim for research and development support may be lodged once the shipment of the goods has been made, against which advance payment has been received.

(18) Applications for research and development support relating to zero period *i.e.* for the shipments made between the 1st July, 2006, and the date of issuance of this Order shall also be submitted by the Authorized Dealers as per the procedure given in this Order. Authorized Dealers are advised to bring the provisions of this Order to the notice of their constituents.

3. **Periodical audit.**— The Federal Government reserves the right to conduct periodical, random, on-the-spot checks and audits to verify the proper usage, disbursement and claim of research and development support claimed under this Order.

4. **Fraud and penalty.**— In case any fraud is detected in claiming the research and development support under this Order, the Textile Commissioner shall be the competent authority to levy fine and penalty up to 300% of the fraudulently claimed amount. The Appellate Authority in this case shall be the Secretary, Ministry of Textile Industry.

5. Monthly reports.— Associations mentioned in sub-paragraph (4) of paragraph (2), shall submit to the Ministry of Textile Industry and the Textile Commissioner's Organization, a statement on a monthly basis giving details of export consignments certified by them, for the purpose of research and development support, giving description of goods with H.S. Codes, amounts, quantities and destinations.

6. **Modifications.**— The Federal Government reserves the right to make any change including additions, deletions and modifications in the scheme under this Order which it may consider necessary or to withdraw the scheme under this Order altogether at any time.

7. **Contravention.**— The Ministry of Textile Industry reserves the right to investigate and levy fine and penalty against any action taken in contravention of this Order.

8. Interpretations.— Any interpretation or clarification required regarding the application of this Order shall be made by the Ministry of Textile Industry.
