

**Declaration to be furnished by E- Commerce Exporters/ Authorized Dealer  
For Registration in WeBOC**

*(Pursuant to section 12(1) of the Foreign Exchange Regulation Act, 1947 read with government Notification No. 1  
(6)-ECS/48 dated the July 1, 1948)*

Goods exported by E-Commerce exporters shall be routed through any courier registered with Pakistan Customs in WeBOC. The courier handling the export shipment shall file the Goods Declaration to Pakistan Customs on behalf of the exporter based on the information submitted by the exporter.

**UNDERTAKING/DECLARATION BY EXPORTER**

1. I/We, hereby declare that I/We am/are the sellers/consignors/exporters of goods routed through E-Commerce Exporters' Module in WeBOC in Pakistan and the particulars to be given by me/us to the courier company in respect of export of goods shall be true and that the invoice value declared to the courier at the time of shipment will be the actual full value as contracted with the buyers.
2. I/We undertake that I/we shall deliver to the bank mentioned above the foreign exchange proceeds resulting from the export of these goods on the due date for payment or within 60 days from the date of shipment/dispatch whichever is earlier.
3. I/We declare that nothing material or relevant to the information as required by State Bank/ Pakistan Customs shall be omitted or suppressed and whatever shall be declared by me to the courier company shall be true to the best of my/our knowledge and belief.
4. I/We undertake to submit to the Authorized Dealer a monthly statement of realization of export proceeds, as per format prescribed by State Bank within 5 working days from the end of month to which the statement pertains.
5. I/We undertaken that in case of non-realization or delay in realization of export proceeds against the export of goods beyond the prescribed period, the State Bank/ Authorized Dealer shall have the authority to take necessary legal action against me/us including but not limited to debarring me/ us from further exports.

An incorrect declaration/ failure to comply with SBP regulations as mentioned above constitutes an offence under Foreign Exchange Regulation Act, 1947.

**CERTIFICATE OF AUTHORIZED DEALER**

1. Certified that the above exporter(s) is/are known to us, that he/they is/are bonafide businessman/business entity in Pakistan and that he/ they has/have made arrangements with us for the realization of the export proceeds, of the goods to be exported from Pakistan, on the due date for payment or within 60 days from the date of shipment, whichever is earlier, in accordance with the State Bank's regulations and that we are satisfied with said arrangements.
2. We undertake to ensure that export proceeds against shipment made by the exporter though E-Commerce Module of WeBOC shall be received by us on the due date for payment or within 60 days from the date of shipment, whichever is earlier, in accordance with the State Bank's regulations. In the event of non-compliance due to reasons beyond our control we shall furnish to the State Bank of Pakistan a full explanation as to the reasons and circumstances resulting in our inability to comply, if so required.
