SUBJECT: SUNDRY DECISION-1 OF THE FEDERAL CABINET IN ITS MEETING HELD ON 03.09.2024

The undersigned is directed to refer to the subject cited above and to state that the Federal Cabinet vide its decision case No. 250/30/2024 dated 03.09.2024, (copy enclosed) has been pleased to approve fifteen days (15) extension in the forty-five days (45) time period already allowed for shipment of export consignment vide its earlier decision in case No.181/22/2024 dated 25.06.2024 in the following manner:

- For the unutilized export quota of sugar mills from Punjab, fifteen (15) days effective from the date of issuance of this decision of the Cabinet; and
- b) For other Provinces the extension period shall commence from the date of allocation of quota by the Provincial Cane Commissioner.
- 2. The Cabinet further decided that above extension shall not apply to the sugar mills which have failed to use export proceeds for payments to growers, in terms of the ECC's decision dated 13.06.2024 and ratified by the Federal Cabinet on 25.06.2024.
- 3. The Cabinet also decided that the Cabinet Committee already constituted vide Cabinet Division's Notification No. F.5/17/2024 dated 25th & 26th June, 2024 will regularly update the Cabinet on the demand, supply and price situation of sugar in the country.
- Federal Cabinet further directed that all other terms and conditions stipulated in the Federal Cabinet decision in Case No.181/22/2024 dated 25.06.2024, shall continue to apply on export of sugar.
- 5. All concerned are requested to implement the decision of the Federal Cabinet in letter and spirit and to facilitate the export of sugar as per the directions of Federal Cabinet.
