



- I. National CPI Inflation (on YoY basis) decreased to 3.2 percent in June 2025 from 3.5 percent in the previous month. It stood at 12.6 percent during the corresponding month of last year. On MoM basis, National CPI showed an inflation of 0.2 percent in June 2025 against a deflation of 0.2 percent in the previous month. During the corresponding month of last year, it showed an inflation of 0.5 percent.
- II. Urban CPI Inflation (on YoY basis) decreased to 3.0 percent in June 2025 from 3.5 percent in the previous month. It stood at 14.9 percent during the corresponding month of last year. On MoM basis, Urban CPI inflation remains same at 0.1 percent both in June 2025 and in the previous month. During the corresponding month of last year, it showed an inflation of 0.6 percent.
- III. Rural CPI Inflation (on YoY basis) increased to 3.6 percent in June 2025 from 3.4 percent in the previous month. It stood at 9.3 percent during the corresponding month of last year. On MoM basis, Rural CPI showed an inflation of 0.5 percent in June 2025 against a deflation of 0.5 percent in the previous month. It showed an inflation of 0.3 percent during the corresponding month of the last year.
- IV. Urban Core (Non-food, Non-energy) Inflation (on YoY basis) decreased to 6.9 percent in June 2025 from 7.3 percent in the previous month. It stood at 12.2 percent in the corresponding month of the previous year. On MoM basis, it decreased to 0.2 percent in June 2025 from 0.4 percent in the previous month. It stood at 0.6 percent during the corresponding month of the last year.
- V. Rural Core (Non-food, Non-energy) Inflation (on YoY basis) decreased to 8.6 percent in June 2025 from 8.8 percent in the previous month. It stood at 17.0 percent during the corresponding month of last year. On MoM basis, it increased to 0.7 percent in June 2025 from 0.4 percent in the previous month. It stood at 0.9 percent in the corresponding month of the last year.
- VI. Urban Core (trimmed) Inflation (on YoY basis) decreased to 4.7 percent in June 2025 from 4.9 percent in the previous month. It stood at 10.3 percent during the corresponding month of the last year. On MoM basis, it increased to 0.3 percent in June 2025 from 0.1 percent in the previous month. It showed an inflation of 0.6 percent during the corresponding month of the last year.


- VII. Rural Core (trimmed) Inflation (on YoY basis) increased to 5.2 percent in June 2025 from 4.7 percent in the previous month. It stood at 11.0 percent in the corresponding month of last year. On MoM basis, it showed a deflation of 0.5 percent in June 2025 against a deflation of 0.2 percent in the previous month. It showed an inflation of 0.5 percent during the corresponding month of last year.
- VIII. WPI (on YoY basis) increased to 0.6 percent in June 2025 from 0.4 percent in the previous month. It showed an inflation of 10.6 percent in the corresponding month of last year. On MoM basis, it showed an inflation of 0.6 percent against 0.0 percent in the previous month. An inflation of 0.4 percent was observed during the corresponding month of last year.
- IX. SPI (Combined) on YoY basis showed a deflation of 1.2 percent in June 2025 against an inflation of 0.1 percent in the previous month. It showed an inflation of 23.0 percent in the corresponding month of last year. On MoM basis, it showed a deflation of 0.5 percent in June 2025 against a deflation of 0.8 percent in the previous month. An inflation of 0.9 percent was observed during the corresponding month of the last year.


1.1 CPI Inflation (YoY)




1.2 Core Inflation (YoY)




1.3 CPI Inflation (YoY) and Policy Rate




1.4 CPI Inflation (YoY) and Currency in Circulation (CIC) Growth (YoY)




1.5 CPI Inflation (YoY) and Large-Scale Manufacturing (LSM) Growth (YoY)






2. Inflation Expectations

Consumer Confidence Survey (CCS) is a stratified random telephonic survey of households across Pakistan conducted on monthly basis¹. Consumers' Inflation Expectations Index for the month of May 2025 decreased by 0.5 percent to reach 63.3 from 66.6 as compared to the last survey.








6.3 Distribution of Price Changes (YoY) in Urban Basket




6.4 Distribution of Price Changes (YoY) in Rural Basket










6.8 Frequency Distribution of Price Changes of Urban CPI Items (YoY)




6.9 Frequency Distribution of Price Changes of Rural CPI Items (YoY)

Technical Notes

1. All the three measures of inflation, viz. CPI (National, Urban and Rural), WPI and SPI are computed by the following Laspeyres Index formula:

$$I_t = \sum_j w_0^j \left(\frac{P_t^j}{P_0^j} \right)$$

Where I_t is price index, w_0^j is weight of commodity j in the overall basket, P_t^j is price of commodity j in period t and P_0^j is its price in the base year.

2. Base year for all the indices is the year 2015-16.
3. CPI baskets for urban and rural areas contains 356 and 244 consumers' items respectively; WPI basket contains 419 items; SPI contains 51 items.
4. YoY inflation is the percent change of an index in a given month over the index in the same month of the last year. It is computed as follows:

$$\pi_t = \left(\frac{I_t}{I_{t-12}} - 1 \right) \times 100$$

5. Period average inflation is the percent change of the average index during the period from July to the given month of a fiscal year over the average index during the corresponding period of the last year. It is computed as follows:

$$\bar{\pi}_t = \left(\frac{\sum_{i=0}^{t-v} I_{t-i}}{\sum_{i=0}^{t-12-v} I_{t-12-i}} - 1 \right) \times 100$$

Where v is the serial number of the month of December of current fiscal year in a given time series.

6. Monthly inflation is the percent change of an index in a given month over the index in the preceding month. It is computed as follows:

$$\pi_t = \left(\frac{I_t}{I_{t-1}} - 1 \right) \times 100$$

7. 12-month moving average inflation (Long-run trend inflation) is the percent change of 12-month moving average of a price index; it is computed as follows:

$$\tilde{\pi}_t = \left(\frac{\sum_{i=0}^{11} I_{t-i}}{\sum_{i=0}^{11} I_{t-12-i}} - 1 \right) \times 100$$

8. Core Inflation is defined as the persistent component of measured inflation that excludes volatile and controlled prices. It reflects the normal supply and demand conditions in the economy. Core inflation is computed by the following two methods i.e. NFNE inflation and trimmed inflation:

- a) Non-food, Non-energy inflation (NFNE inflation); it is computed by excluding food group and energy items (kerosene oil, petrol, diesel, CNG, electricity and natural gas) from the CPI basket.
- b) 20% trimmed-mean inflation; it is computed through the following steps:
- i. All CPI items are arranged in ascending order according to YoY/12-month moving average/monthly/period average changes in their price indices in a given month.
 - ii. 20 percent of the items showing extreme changes are excluded with 10 percent of the items at the top of the list (corresponding to cumulative weight of 90% or more) and 10 percent of the items at the bottom of the list (corresponding to cumulative weight of 10 percent or less).
 - iii. The weighted mean of the changes in price indices of the rest of the items is core inflation.
9. Weighted contribution of different items (or sub-groups) to total inflation is worked out as below:
Let the overall index (I_t) is the weighted average of price indices of individual items or sub-groups (I_{it}), i.e.

$$I_t = \sum_i w_i \cdot I_{it}$$

The weighted contribution of a single item (or a sub-group) to overall inflation is defined as:

$$C_{it} = \alpha_{it-12} \cdot w_i \cdot \left(\frac{\pi_{it}}{\pi_t} \right)$$

Where C_{it} : Contribution of i^{th} item to the overall inflation

$$\alpha_{it-12} = \frac{I_{it-12}}{I_{t-12}} ; \text{ i.e. ratio of item's index to overall index in the reference month}$$

w_i : Weights of i^{th} item

π_{it} : Inflation of i^{th} item

π_t : Overall inflation
