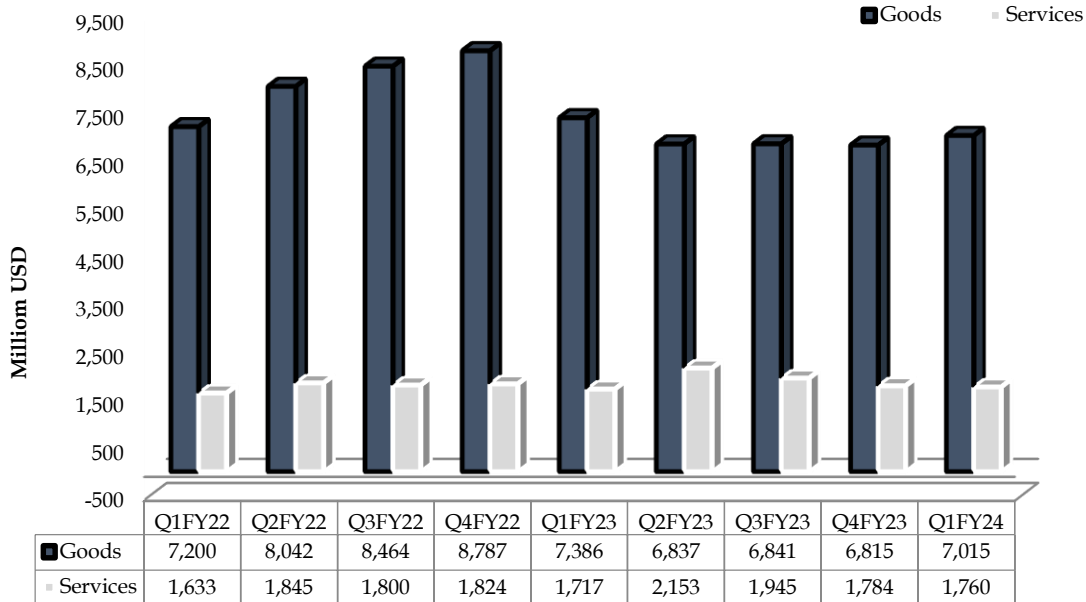

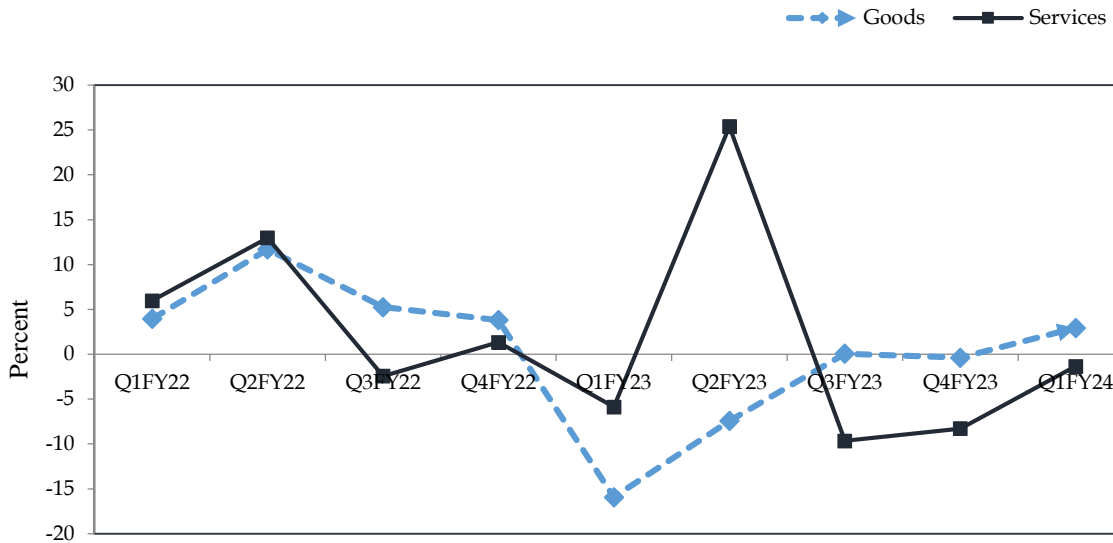

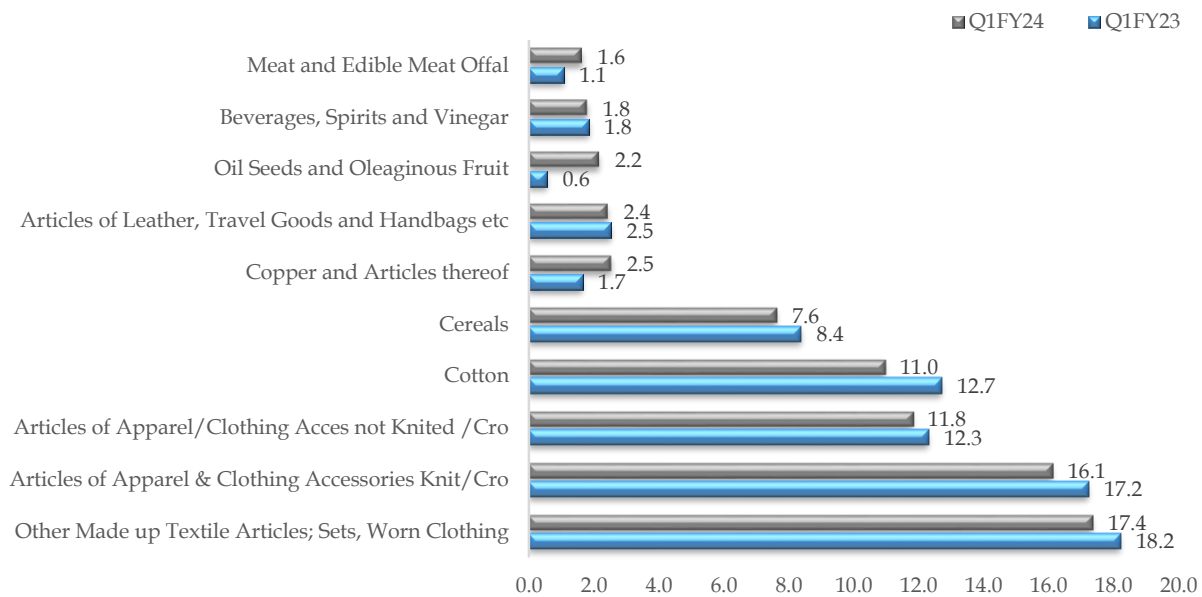


Export Receipts by Major Groups of Goods and Services

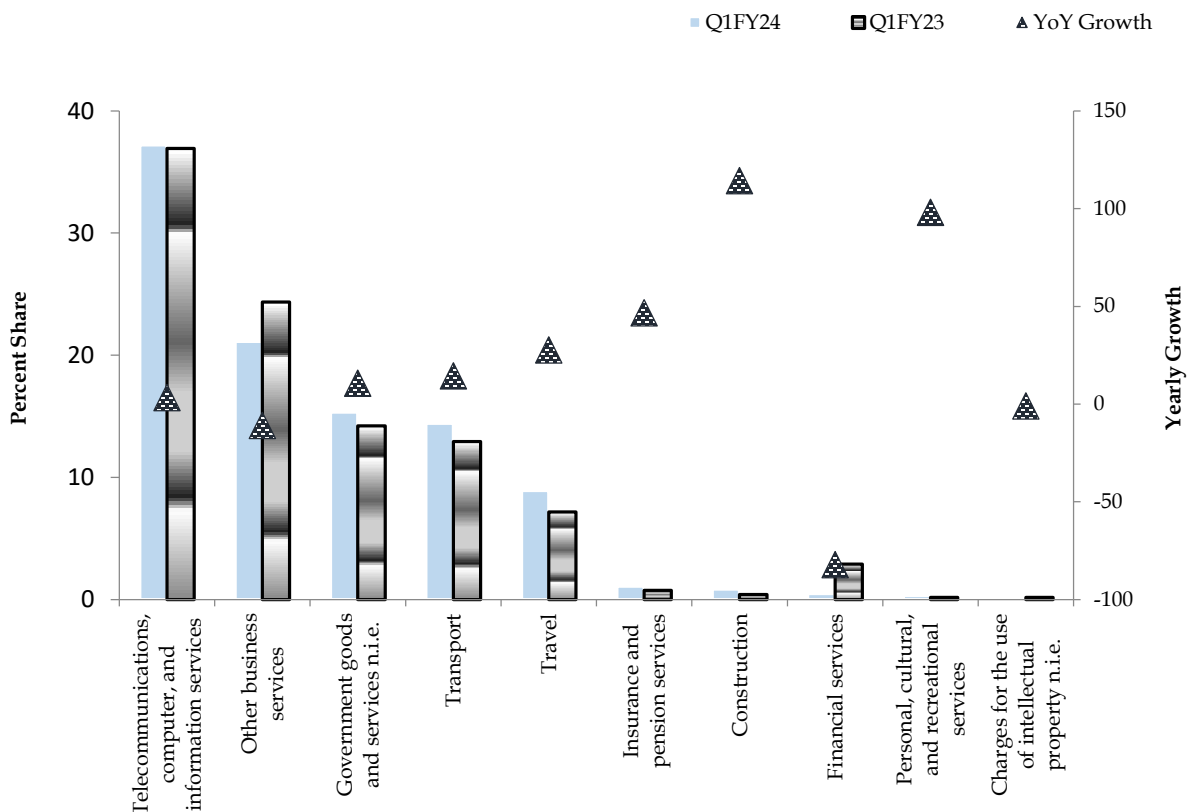

Export of Services (By Type) **Figure 4**



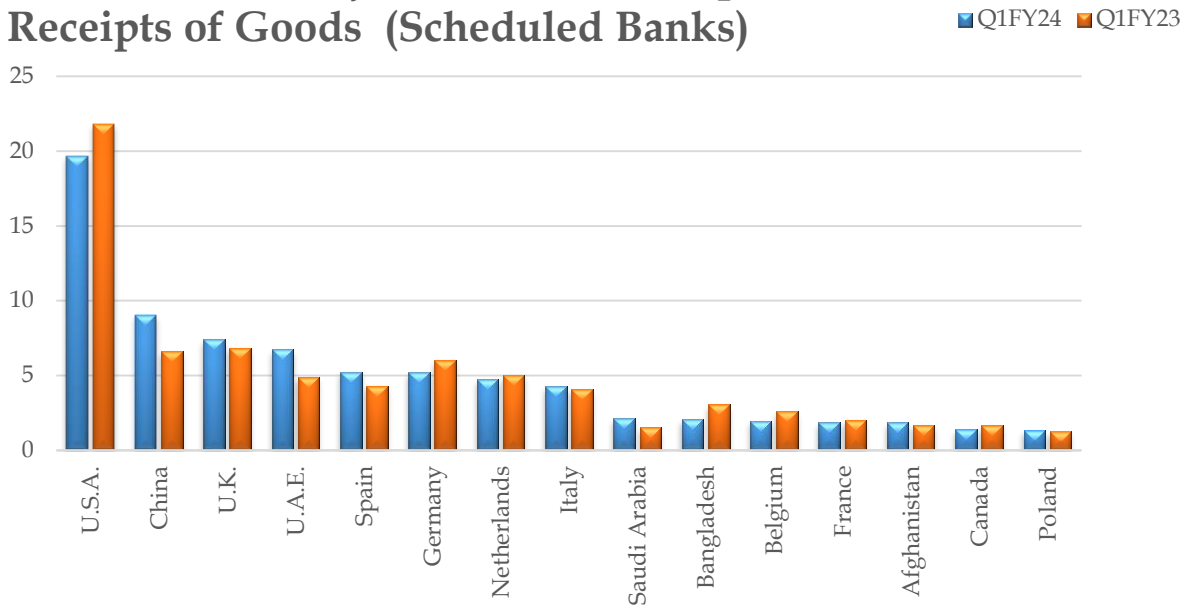

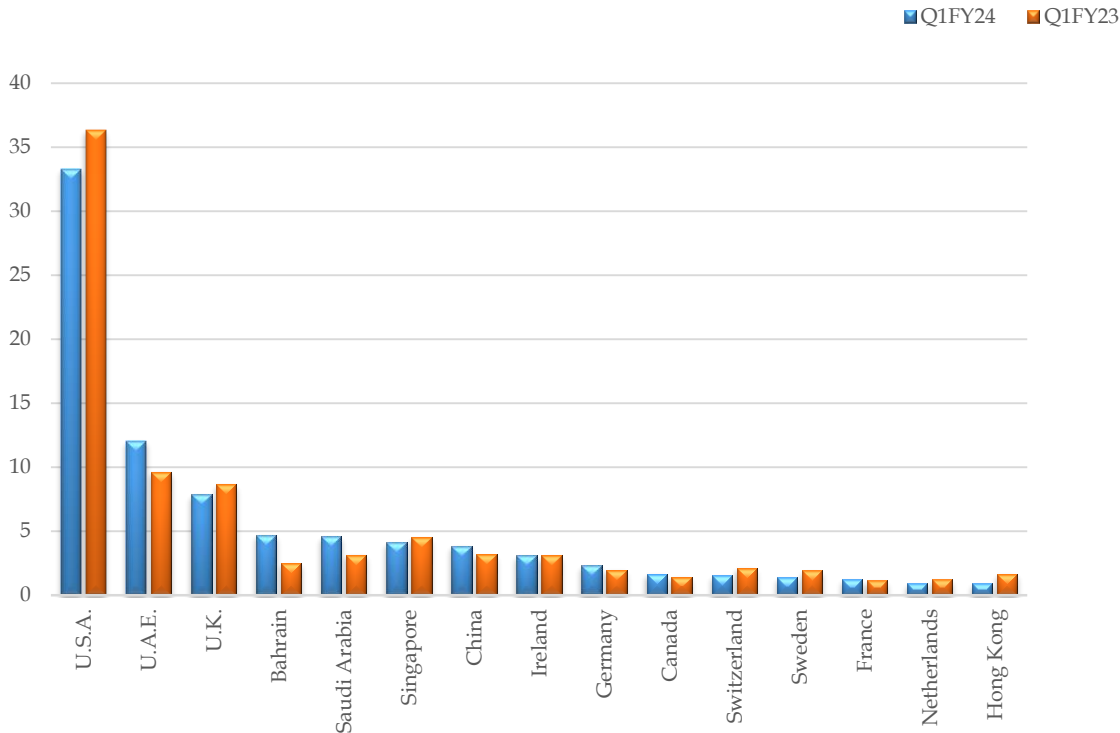
Percent Share of Major Countries in Export Receipts of Goods (Scheduled Banks)

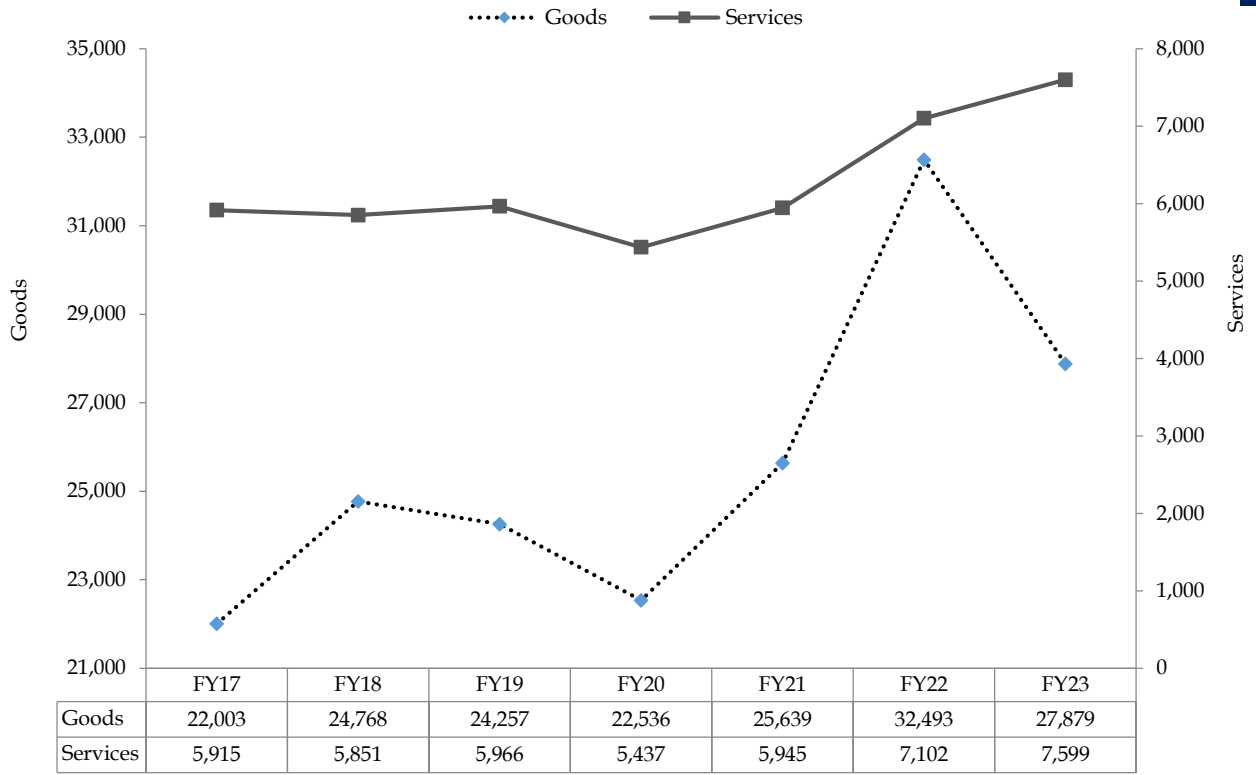
Percent Share of Major Countries in Export of Services
