The deficit on the current account of the balance of payment computed from these data does not equal the estimates of external resource inflow provided by Planning Division (Table -2.4 of SBP Annual Report FY 06) as the latter is based on Balance of Payment data compiled on the basis of Payments for imports and receipts from exports.
- (3) The figure of net factor income from abroad given in the table includes the imputed value of accompanied personal baggage whereas Planning Division's estimates of this variable (Difference of national and domestic savings given in Table-2.4 of SBP Annual Report FY 06) exclude personal baggage.
