 - iv. Bidder must have documented experience of completing at least five (5) public address systems involving supplies, installation and support services of a comparable scale during last five (5) years at High Valued Buildings in Pakistan;
 - v. Bidder must be registered with Income Tax & Sales Tax Departments and must appear on Active Taxpayers List (ATL) of FBR;
 - vi. Bidder must not be insolvent, bankrupt and is not blacklisted or debarred by PPRA, Government, Semi-Government, Private, Autonomous body or any other international organization;
 - vii. Successful bidder will be required to supply the equipments/system within six (6) weeks of award of notification;
- 3. All bids must be accompanied by a bid security of not less than **two (2%) percent (refundable) of the bid price,** must be accompanied by Financial Proposal. Bidders will submit quotations of COMPLETE CONTRACT PACKAGE, evaluation of bid and contract award will be done accordingly.
- 4. The rates quoted must remain valid for a period of **ninety (90) days** after opening of bids.
- 5. Bidding documents containing detailed terms and conditions etc are available for the interested bidders from the address given below on submission of a written application (company letterhead) upon payment of **Rs.500/- (Non refundable)** only through bank draft/pay order in favor of NIBAF Islamabad from the office of Joint Director (Procurement), NIBAF Islamabad during office hours after publication of IFB till closing thereof.
