1. General Services Unit, SBP Banking Services Corporation (BSC) Rawalpindi Office invites sealed bids for “Supply, Installation, Testing and Commissioning of IP Based Security cameras” at SBP BSC (Bank) - Rawalpindi with all accessories as detailed in the bidding documents.
2. Bidding will be conducted under National Competitive Bidding pursuant to ‘Single stage two envelopes procedure’ as per Rule 36(b) of Public Procurement Rules 2004 (PPR 2004) and is open to all eligible Bidders as defined in the PPR 2004 that meet the following minimum eligibility/qualification criteria:
  - a. Bidder must be registered with Income and Sales Tax Department and also appear on Active Taxpayers List (ATL) of FBR.
  - b. Bidders must be a Manufacturer (OEM) or an authorized Agent /Partner of the manufacturer for last 3 (three) consecutive years.
  - c. Bidders must be authorized by their OEM(s) specifically for this procurement.
  - d. The offered product(s) must have been installed at minimum 3 verifiable organizations in Pakistan during last 3 years.
  - e. Bidder must have technical strength of at least 2(Two) OEM Certified and Trained Engineers above entry/associate level.
  - f. Bidder must have Annual Sales Volume/Gross Turnover of at least 1.0 million rupees, in any of last 03(three) years;
3. The bidders must quote only one type/model of equipment, meeting the technical specifications required by the Bank. Technical brochure containing detailed specifications of the said item should be provided with the bid.
4. Interested eligible bidders may obtain the bidding documents on submission of a written application on their firms’ letter head to the address below upon payment of Rs.500/- (non-refundable) in the shape of bank draft/pay order. If the bidding documents are requested by post courier then non-refundable fee of Pak Rs.700/- will be charged.
5. The bids, prepared in accordance with the instructions in the bidding documents, must reach at office of the undersigned on or before **Friday, 17-05-2019, 11:00 am**. Bids will be opened in the presence of bidders’ representatives who choose to attend at 11:30 AM same day in the office of PA to Chief Manager, SBP-BSC (Bank), Rawalpindi.
