**PROVIDING AND FIXING OF MOVABLE WORKSTATIONS AT SBP BSC SIALKOT**

1. General Services Unit, Sialkot Office, SBP Banking Services Corporation (BSC) invites sealed bids for “Providing and Fixing of Movable Workstations at SBP BSC Sialkot Office” as detailed in the bidding documents.

Bidding will be conducted under National Competitive Bidding pursuant to ‘**Single stage two envelopes procedure**’ as per Rule 36(b) of Public Procurement Rules 2004 (PPR 2004) and is open to all eligible Bidders as defined in the PPR 2004 that meet the following minimum eligibility/qualification criteria:
  - a. Bidder must be registered with Income and Sales Tax Department and also appear on Active Taxpayers List (ATL) of FBR.
  - b. Bidders must be a Manufacturer or authorized Agent /Partner of the manufacturer for the required items in Pakistan.
  - c. Bidder must have documented experience of two (02) assignments of provision of workstations/similar furniture items amounting to Rs. 0.5 million each in Pakistan during last three (03) years
  - d. Bidder must have support/branch offices in Sialkot or nearby cities to provide technical support.
  - e. Bidder must have liquid assets of Rs. 300,000/- or above at any time in the last three months.

Bidding documents containing detailed terms and conditions, etc. are available for the interested bidders from the address given below on submission of a written application upon payment of a nonrefundable fee of **Rs.1000/-** (one thousand only) through Bank Draft/Pay Order drawn in favor of SBP BSC (Bank).
