The State Bank of Pakistan Banking Services Corporation (SBP BSC) intends to procure "Supply, Installation, Testing, Commissioning and Maintenance of CCTV Surveillance including IP based CCTV Cameras, NVRs (with hard drives), Enterprise Video Storage, Network Switches, LED TV Displays, Cabling and allied equipment" for its different field offices. Sealed bids are invited from all eligible Bidders meeting the following eligibility criteria:

- a. Bidder must be an Original Equipment Manufacturer (OEM) or a direct authorized agent of the OEM of the offered models in Pakistan;
- b. Bidder must have supplied the similar system to at least four (04) verifiable organizations in Pakistan in last three (03) years;
- c. Bidder must have verifiable presence in three (03) major cities of Pakistan (i.e. Karachi, Lahore, Islamabad,);
- d. Bidder must have technical strength of at least 06 (six) technicians/trained resources to be able to carry out the maintenance and repair;
- e. Bidder must have Annual Sale / Gross Turnover of at least Rs. 50 million in any of the last 03 (three) financial years;
- f. Bidder shall not be blacklisted or in breach of performance with SBP or any Government Organization(s).
- g. Bidder must be registered with Income and Sales Tax Department and also appear on Active taxpayers List (ATL) of FBR.
- h. Bidding documents containing detailed terms and conditions, etc. are available against payment of Rs. 1,000/- (non-refundable) in the form of payment order / demand draft drawn in favor of SBP BSC (Bank) for the interested bidders on submission of a written application from the address given below from 9:00 am to 5:30 pm after publication of IFB till closing thereof.
- i. Site Surveys of all 16 SBP BSC field offices shall be conducted by prospective bidders before the pre-bid meeting scheduled on **Monday**, **September 28**, **2020**. Site surveys shall be conducted from **Monday**, **August 24**, **2020** to **Friday**, **September 18**, **2020**. The site surveys shall be a onetime exercise arranged for all bidders at the decided date.
- j. The bids, prepared in accordance with the instructions in the bidding documents, must reach at office of the undersigned on or before **Thursday**, **October 15**, **2020** at 11:00 am. Bids will be opened on same day at 11:30 am, at General Services Department, 4th Floor, BSC House, State Bank of Pakistan, I.I Chundrigar Road, Karachi –Pakistan.
