The consultants who are on active tax payer list of Federal Board of Revenue, Sindh Revenue Board (SRB) and have valid PEC registration in relevant disciplines in project profile code 1201 are invited to participate. If the bidder is not registered with SRB, then upon payment 100% deduction will be made as per applicable laws.

The technical and financial proposals (Volume - I & II) must be sealed in two separate envelopes and be placed in 3rd outer envelope. The name of the bidder and Bid description (Name and technical or financial proposal) shall be clearly marked on all envelopes. Bids should be dropped in Bid box kept in the office of the PA to Director Engineering, 1st floor SBP BSC, Bolton Market Office Building, M.A. Jinnah Road, Karachi on or before **18th March 2021 till 11:00 AM.** The Technical Proposals shall be opened on same date and venue at **11:30 AM.** In case opening date is falling on a public holiday, the bid will be opened on next working day at the same time and venue.
