## INVITATION TO BID

## CONSTRUCTION OF SBP NEW OFFICE BUILDING AT D.I. KHAN

- The State Bank of Pakistan Banking Services Corporation (SBP BSC) invites sealed bids, from the eligible bidders registered with Income Tax and Sales Tax Departments and who are on Active Taxpayers List of the Federal Board of Revenue (Sales Tax and Income Tax) and having valid PEC registration in C-1 or above with specialization codes CE-10, ME-01, EE-04 and EE-05 for "Construction of SBP New Office Building at D.I. Khan". The bidders must be registered with Khyber Pakhtunkhwa Revenue Authority (KPRA), if not registered with KPRA, then upon payment, 100% deduction of tax will be made as per applicable laws.

Please collect Bidding Documents, containing detailed terms and conditions, etc. from Office of the Executive Engineer (Phone # 021-32454169), Engineering Department, State Bank of Pakistan SBP BSC, 1<sup>st</sup> floor SBP Bolton Market Building, M.A. Jinnah Road, Karachi or Office of the Assistant Executive Engineer (Phone # 051-9078304), Engineering Unit, 1<sup>st</sup> floor, State Bank of Pakistan, SBP BSC (Bank), Ataturk Avenue, Sector G-5/2, Islamabad. The firms are required to submit their application on letterhead for issuance of Bidding Documents along with Pay order / demand draft of Rs. 20,000/- (Non-Refundable) for above work drawn in favor of the State Bank of Pakistan Banking Services Corporation as Bidding Documents fee. The bidding will be conducted under National Competitive Bidding Procedure specified in the Public Procurement Rules 2004 as per Rule-36(b), under Single stage two envelope procedure.
- Bidders are strictly advised to visit the project site (<u>https://goo.gl/maps/pxk4DD736B4WZbTE9</u>). The site can be visited on <u>12<sup>th</sup> and 13<sup>th</sup> January, 2022</u> at <u>11:00AM</u>. In-case site visit is falling on public holiday(s), the same will be conducted on next working day(s) at the same time. Pre-Bid meeting will be held on <u>14<sup>th</sup> January, 2022</u> at <u>11:00AM</u> either physically at State Bank of Pakistan, SBP BSC (Bank), Ataturk Avenue, Sector G-5/2, Islamabad or (in case of COVID restrictions) virtually via **Zoom Video** Conferencing, for which link will be shared with bidders who have purchased Bidding Documents. In-case Pre-Bid meeting is falling on public holiday, the same will be conducted on next working day at the same time and venue.
- Any prospective bidder requiring any clarification(s) in respect of the Bidding Documents may notify the Employer in writing 21 days (i.e. 20<sup>th</sup> January, 2022) prior to the deadline for submission of bids.

All bids must be submitted in accordance with the instructions in the Bidding Documents, and be dropped in the tender box kept in the Office of PA to Director Engineering, Engineering Department, State Bank of Pakistan SBP BSC, 1<sup>st</sup> floor SBP Bolton Market Building, M.A. Jinnah Road, Karachi on or before <u>10<sup>th</sup> February, 2022</u> till <u>03:00PM</u> along with Bid Security of Rs. 30 Million in the form of Deposit at Call or Pay Order or Demand draft or Banker's Cheque or a Bank Guarantee issued by a Scheduled Bank in Pakistan or from a foreign bank duly counter guaranteed by a Scheduled Bank in Pakistan or an insurance company having at least AA rating from PACRA/JCR in favour of the State Bank of Pakistan Banking Services Corporation on prescribed Form of Bid Security (BS-1&2) given in the Bidding Documents. Bids will be opened on the same day at the same venue at <u>03:30PM</u>.
