	b	) <b>"Applicable Law"</b> means the laws and any other instruments having the force of law in Pakistan or another country as may be specified in the <b>Data Sheet</b> , as they may be issued and in force from time to time.
	c	) "Authority" means Public Procurement Regulatory Authority.
	d	) <b>"Consultant"</b> means a legally-established professional consulting firm or an entity that may provide or provides the Services to the Procuring Agency under the Contract.
	e	) "Contract" means a legally binding written agreement signed between the Procuring Agency and the Consultant and includes all the attached documents listed in Clause 1 (the General Conditions of Contract (GCC), the Special Conditions of Contract (SCC), and the Appendices).
	f)	<b>"Data Sheet"</b> means an integral part of the Instructions to Consultants ( <b>ITC</b> ) that is used to reflect specific country and assignment conditions to supplement, but not to over-write, the provisions of the <b>ITC</b> .
	g	) <b>"Day"</b> means a calendar day.
	h	) <b>"Experts"</b> means, collectively, Key Experts, Non-Key Experts, or any other personnel of the Consultant, Sub-consultant or Joint Venture member(s).

		n) <b>"Procurement Regulatory Framework"</b> means Public Procurement Rules, 2004 (PPR-2004) and Procurement of Consultancy Services Regulations, 2010 (PCSR-2010).
		o) <b>"Procuring Agency"</b> means the State Bank of Pakistan. However, on behalf of the Procuring agency, the procurement process shall be managed by <b>SBP Banking Services</b> <b>Corporation</b> , hereinafter called the <b>"Bank,"</b> which is a wholly- owned subsidiary of the State Bank of Pakistan and was set up in January 2002 through SBP Banking Services Ordinance, 2001.
		p) <b>"Proposal"</b> means the Technical Proposal or the Financial Proposal of the Consultant.
		q) <b>"RFP"</b> means the Request for Proposals issued by the Procuring Agency for soliciting technical and financial proposals from the Consultant.
		r) <b>"Services"</b> means the activities and tasks to be performed by the Consultant under the Contract.
		s) <b>"Sub-consultant"</b> means an entity to whom the Consultant intends to subcontract any part of the Services while remaining responsible to the Procuring Agency during the performance of the Contract.
		t) <b>"TORs"</b> means the Terms of Reference that explain the objectives, scope of services, respective responsibilities of the Procuring Agency and the Consultant, and expected results and deliverables of the assignment.
2. Introduction	2.1.	The Procuring Agency named in the <b>Data Sheet</b> intends to select a Consultant in accordance with the method of selection specified in the <b>Data Sheet</b> . The eligible Consultants are invited to submit a Technical Proposal and a Financial Proposal for consulting services named in the <b>Data Sheet</b> . The Proposal will be the basis for negotiating and ultimately signing the Contract with the selected Consultant.
	2.2.	The Consultants should familiarize themselves with the local conditions and take them into account in preparing their Proposals, including attending a pre-proposal conference if one is specified in the <b>Data Sheet</b> . Attending any such pre-proposal conference is optional and is at the Consultants' expense.

	2.3.	The Procuring Agency will timely provide, at no cost to the Consultants, the inputs, relevant project data, and reports required to prepare the Consultant's Proposal if specified in the <b>Data Sheet</b> .
3. Conflict of Interest	3.1.	The Consultant is required to provide professional, objective, and impartial advice, at all times holding the Procuring Agency's interests paramount, strictly avoiding conflicts with other assignments or its corporate interests, and acting without any consideration for future services.
	3.2.	The Consultant must disclose to the Procuring Agency any actual or potential conflict that impacts its capacity to serve the best interest of its Procuring Agency. Failure to disclose such situations may lead to the disqualification of the Consultant or the termination of its Contract and/or sanctions by the Procuring Agency.
	3.3.	Without limitation on the generality of the foregoing, the Consultant shall not be hired under the circumstances set forth below:
		(a) <b>Conflicting Activities:</b> A Consultant that the Procuring Agency has engaged for providing goods, works, or non-consulting services for a project, or any of its Affiliates, shall be disqualified from providing consulting services resulting from or directly related to those goods, works, or non-consulting services. Conversely, a firm hired to provide consulting services for the preparation or implementation of a project or any of its Affiliates shall be disqualified from subsequently providing goods or works or non-consulting services resulting from or directly related to the consulting services for such preparation or implementation.
		(b) <b><u>Conflicting Assignments</u></b> : A Consultant (including its Experts and Sub-consultants) or any of its Affiliates shall not be hired for any assignment that, by its nature, may conflict with another assignment of the Consultant for the same or another Procuring Agency.
		(c) <u>Conflicting Relationships</u> : A Consultant (including its Experts and Sub-consultants) that has a close business or family relationship with a professional staff of the Procuring Agency, who are directly or indirectly involved in any part of (i) the preparation of the Terms of Reference for the assignment, (ii) the selection process for the Contract, or (iii) the supervision of the Contract, may not be awarded a Contract unless the conflict stemming from this relationship has been resolved in a manner acceptable to the Procuring Agency throughout the selection process and the execution of the Contract.
4. Unfair Competitive Advantage	4.1.	Fairness and transparency in the selection process require that the Consultants or their Affiliates competing for a specific assignment do not derive a competitive advantage from having provided consulting services related to the assignment in question. To that end, the Procuring Agency shall indicate in the <b>Data Sheet</b> and make all eligible Consultants available with this RFP all information

			that would, in that respect, give such Consultant any unfair competitive advantage over competing Consultants.
5.	Corrupt and Fraudulent Practices	5.1.	The Procuring Agency requires compliance with the Public Procurement Regulatory Framework regarding corrupt and fraudulent practices as outlined in <b>Rule 2(1)(f)</b> of the <b>Public</b> <b>Procurement Rules,2004 (PPR 2004).</b> Under Rule 19 of PPR- 2004, the Procuring Agency can inter alia blacklist the Consultants indulging in corrupt or fraudulent practices. Such barring action shall be duly publicized and communicated to the Authority.
		5.2.	In further pursuance of this Regulatory Framework, Consultants shall permit and shall cause their agents (whether declared or not), sub-Consultants, sub-consultants, service providers, suppliers, and personnel, to permit the Procuring Agency to inspect all accounts, records and other documents relating to any shortlisting process, Proposal submission, and contract performance (in the case of award), and to have them audited by auditors appointed by the Procuring Agency.
6.	Eligible Consultants	6.1.	The Procuring Agency permits consultants (either individually or through Joint Venture/Sub-Consultant) as specified in <b>Data Sheet</b> to offer consulting services for the project.
		6.2.	Furthermore, it is the Consultant's responsibility to ensure that its Experts, joint venture members, Sub-consultants, agents (declared or not), service providers, suppliers and/or their employees meet the eligibility requirements.
		6.3.	As an exception to the foregoing <b>Clauses 6.1 and 6.2</b> above:
			(a) <b>Sanctions:</b> A firm or an individual declared blacklisted by the Procuring Agency/Authority shall be ineligible to participate in the procurement process or to be awarded a contract during such period. The debarred firms and individuals' list is available at the electronic address specified in the <b>Data Sheet</b> .
			(b) <b>Prohibitions:</b> Firms and individuals of a country may be ineligible if so indicated in <b>Section V (Eligible Countries).</b>

		B. PREPARATION OF PROPOSALS
7. General Considerations	7.1.	In preparing the Proposal, the Consultant is expected to examine the <b>RFP</b> in detail. Material deficiencies in providing the information requested in the <b>RFP</b> may result in the proposal's rejection.
8. Cost of Preparation of Proposal	8.1.	The Consultant shall bear all costs associated with the preparation and submission of its Proposals, and the Procuring Agency shall not be responsible or liable for those costs, regardless of the conduct or outcome of the selection process. The Procuring Agency is not bound to accept any proposal and reserves the right to annul the selection process under the procurement regulatory framework at any time before the Contract award without thereby incurring any liability to the Consultant.
9. Language	9.1.	The Proposal, all correspondence and documents relating to the Proposals exchanged between the Consultant and the Procuring Agency, shall be written in the language(s) specified in the <b>Data Sheet.</b>
10. Documents Comprising the Proposal	10.1.	The Proposal shall comprise the documents and forms listed in the <b>Data Sheet</b> .
11. Only One Proposal	11.1.	The Consultant (including the individual members of any Joint Venture) shall submit only one Proposal, either in its name or as part of a Joint Venture in another Proposal. If a Consultant, including any Joint Venture member, submits or participates in more than one proposal, all such proposals shall be disqualified and rejected. However, this does not preclude a Sub-consultant or the Consultant's staff from participating as Key Experts and Non-Key Experts in more than one Proposal when circumstances justify and if stated in the <b>Data Sheet</b> and subject to regulatory instructions, if any.
12. Proposal Validity	12.1.	Proposals shall remain valid for the period specified in the <b>Data</b> <b>Sheet</b> after the Proposal submission deadline prescribed by the Procuring Agency. To ensure the proposal's validity, it shall contain the Bid Securing declaration as a complementary proposal securing instrument having the validity <b>twenty-eight (28) days</b> more than the proposal validity period.
	12.2.	During this period, the Consultant shall maintain its original Proposals without any change, including the availability of the Key Experts and the total price.

The Procuring Agency will respond in writing/via email (including an explanation of the query but without identifying its source) to all Consultants (those who obtained the RFP document) and/or uploading on the <u>www.sbp.org.pk</u> .
	14.2.	At any time before the proposal submission deadline, the Procuring Agency may amend the <b>RFP</b> by issuing an amendment in writing/via email. The amendment shall be directly sent to those Consultants, who obtained the RFP document from the Procuring Agency and will be uploaded on the <u>www.sbp.org.pk</u> for all prospective Consultants. The amendment(s) will be binding on all participating consultants.
		(a) If the amendment is substantial, the Procuring Agency may extend the proposal submission deadline to give the prospective Consultants reasonable time to take an amendment into account in their Proposals.
		(b) The Consultant who has already submitted the proposal prior to any amendments in the RFP, may submit a modified Proposal or a modification to any part of it based on the respective amendment in the RFP at any time prior to the proposal submission deadline. 15. Technical Proposal Format and Content	15.1.	The Technical Proposal shall not include any information regarding Financial Proposal. A Technical Proposal containing material financial information shall be declared non-responsive.
	15.2.	The consultants will submit the proposals by using the Standard Forms provided in <b>Section III</b> of the <b>RFP</b> .
16. Financial Proposal	16.1.	The Financial Proposal shall be prepared using the Standard Forms provided in <b>Section IV</b> of the <b>RFP</b> . It must include all costs associated with the assignment. No subsequent price adjustment shall be made except to the provision given in <b>16.1 (a)</b> .
		(a) <u>Taxes</u> : The Consultant and its Sub-consultants and Experts are responsible for meeting all tax liabilities arising out of the Contract unless stated otherwise in the <b>Data Sheet</b> . Information on taxes in the Procuring Agency's country is provided in the <b>Data Sheet</b> .
		(b) <u>Currency of Proposal</u> : The Consultant may express the price for its Services in the currency or currencies as stated in the Data Sheet.
		(c) <u><b>Currency of Payment:</b></u> Payment under the Contract shall be made in the currency or currencies in which the payment is requested in the Proposal.

An authorized representative of the Consultant shall sign the original submission letters in the required format for both the Technical Proposal and the Financial Proposal and shall initial all pages of both. The authorization shall be in the form of a written power of attorney attached to the Technical Proposal.
	17.3.	A Proposal submitted by a Joint Venture shall be signed by all members so as to be legally binding on all members, or by an authorized representative who has a written power of attorney signed by each member's authorized representative.
	17.4.	Any modifications, revisions, interlineations, erasures, or overwriting shall be valid only if they are signed or initialed by the person signing the Proposal.
	17.5.	The signed Proposal shall be marked <b>"ORIGINAL"</b> , and its copies marked <b>"COPY"</b> as appropriate. The number of copies is indicated in the <b>Data Sheet</b> . All copies shall be made from the signed original. If there are discrepancies between the original and the copies, the original shall prevail.

The State Bank of Pakistan (SBP), established under the State Bank of Pakistan Act 1956, aims to achieve domestic price stability by regulating Pakistan's monetary and credit system. Without prejudice to said primary objective, SBP contributes to the stability of Pakistan's financial system and supports the Federal Government's general economic policies to foster development and fuller utilization of the country's productive resources.
