The RFQ can be obtained through an application on the letter head of the firm/ company. The prospective bidders may download the RFQ from procuring agency's website i.e. www.sbp.org.pk and submit the RFQ in accordance with the given requirements, duly signed & stamped by the authorized person.

4. Validity of Bids from the opening date: 90 Days

5. Defect Liability Period: <u>365 days after completion of works</u>

6. Warranty Period: 01 Year for AC & 03 Years for Compressor.

7. **Mode of Payment: 90%** after completion of work & **10%** on the completion of defect liability period.



- 8. The bidder shall submit the technical documents of the AC complying with the B.O.Q. in case of non-compliance with the specifications of BOQ. The bidder shall be held non-responsive.
- 9. The bidders/Firms should be registered with Income Tax Department and General Sales Tax Department and Active Tax Payers List (ATL) of the Federal Board of Revenue/AJK Council. GST and Income Registration certificate to be attached with bid. If the bidder is not in ATL, the bidder shall be held non-responsive.
- 10. The bidders/firms should be registered with relevant Sales Tax Authority/Department/Board. (If the bidder/firm is not registered 100% applicable sales/services tax shall be deducted by the Bank at source)
- 11. Quotations shall be opened on the date, time and venue as mentioned above in the presence of bidders or their authorized representatives who may like to be present.
- 12. Bidders are advised to visit the site before submitting quotations. By submitting the quotations, it is deemed that bidders are fully aware of site conditions and requirements.
- 13. Bids will be checked by the Employer for any arithmetic errors. Where there will be a discrepancy between the unit rate and the line item total resulting from multiplying the unit rate by the quantity, the unit rate as quoted will govern. The amount stated in the Bid will be adjusted by the Employer accordingly and, with the concurrence of the Bidder, shall be considered as binding upon the Bidder. If the Bidder does not accept the corrected amount, the Bid will be rejected.
- 14. The Employer will reject a proposal for award if it determines that the Bidder recommended for award has engaged in corrupt or fraudulent practices in competing for the contract in question like pooling, or giving bribery/ prizes or any sum of money etc. to the persons responsible or engaged in procurement or to other prospective bidders; or the Employer will declare a firm ineligible, either indefinitely or for a stated period of time, to be awarded a contract within its jurisdiction if it at any time determines that the firm has engaged in corrupt or fraudulent practices in competing for, or in executing, a contract.
- 15. Sub-Contracting is not allowed under any circumstances.
- 16. Contractors are advised to make good any damages rendered during the job at their own expense, and must bring the site to original condition and state of cleanliness after job completion.
- 17. Contractor is responsible for the safety of his staff.
- 18. Contractors are obliged to dispose of waste and debris after approval of the Engineer In-charge.
- 19. Material must be of genuine origin as mentioned. Bank reserves the right to demand and check purchase documentation of the contractor to verify genuineness of material.
- 20. Manufacturer's warranty cards must be attached wherever applicable with delivery challan/GRN.
- 21. No price adjustment shall be made for any variation in the market prices, taxes/ duties or change in wages or the Law.
- 22. No advance payment shall be made by the Bank to the Contractor.
- 23. If any dispute arises between the parties (the firm & the Employer), the matter shall be referred to the Director Engineering who will examine the matter in detail and give the decision which will be final & binding upon the parties.
- 24. For valuation of variations and approval of rates for non-BOQ/extra items, the decision of the Director/Head Engineering will be final & binding upon the parties.
- 25. The firm shall keep strictly confidential and not make use of any confidential information supplied by the Employer other than to perform this Contract, and shall impose the same obligations on its employees.
- 26. Bank/ employer reserve the right to reject any or all of the bids as per PPRA rules.
- 27. All applicable taxes/ levies etc. shall be deducted at source from the firm's payable amounts at the prevailing government rates at the time of payment.
- 28. Those firms who have failed to perform previously with SBP / SBP BSC are not eligible to bid.
- 29. In case of any breach of any terms & conditions, SBP-BSC reserves right to take punitive action for which decision of the Director of Engineering shall be conclusive.



- 30. In case of late completion a  $\boldsymbol{penalty}$  of  $\boldsymbol{Rs.}$  500 /  $\boldsymbol{day}$  will be imposed.
- 31. Bid must be un-conditional, incomplete and conditional bid will be rejected.
