DISPOSAL OF UNSERVICEABLE ITEMS PLACED AT SBP MULTAN

1. State Bank of Pakistan, SBP BSC (Bank), Multan Office, invites sealed offers from the interested parties for the disposal of unserviceable items including unserviceable items as package wise detailed below:

Package 1	Cash handling Machines
Package 2	Air conditioners
Package 3	Scrap Items including computer chairs, water dispensers, cooler, refrigerator, geyser, television, fans, heater, iron strips, iron/plastic/wooden/cloth scrap

2. The items are lying in premises of SBP Multan Office on an **“As is where is basis”**. Interested firm/company may visit the bank for disposal items during office hours.
3. Gate Money amounting to Rs. 3000/- (Rupees three thousand only) in the form of Pay order/demand Draft shall have to be deposited by the prospective firm/company for participation. Otherwise, Cheque or cash will not be acceptable. The aforementioned gate money will be returned to the unsuccessful firm/company through written request and authority letter on company letterhead after lifting of disposal by the successful bidder.
4. The firm offering highest bid will be declared as **“SUCCESSFUL”**, and have to deposit 100% of the total offer price in form of pay orders/Bank draft within Seven (07) working days after the letter of acceptance, failing which, the above mentioned security amount will be forfeited and the bank reserves the rights to award the work to the Next Highest Bidder.
5. Lifting to be undertaken by successful firm/company after full payment and the firm will remove and lift the items at their own safety, risk, cost and labour from SBP premises within 07 working days.
6. The Bank is held harmless from any/all claims and losses, acquiring from or resulting to any/all bidders, materials, labors, and any other person. In connection with the performance of this public auction, bidders must accept all responsibility for being aware of which items are currently available for bid.
7. If the bidders have any queries, regarding any item mentioned in the document, the same shall be communicated to the Bank at least 07 days prior to the date fixed for submission/opening of the quotations.
8. Offers must be received on or before March 11, 2022 sharp 11:00 AM. Offers will be opened on same day at 11:30 AM, at Mezzanine floor, SBP BSC Multan.
9. This Disposal Notice is only an invitation to offer and SBP BSC Bank reserves the right to accept or reject all offers at any time.
10. Disposal documents containing detailed terms and conditions etc. are available free of cost for the interested eligible bidders upon submission of a written application with copy of CNIC to this office.
